Notice of Funding Availability for HUD's Fiscal Year (FY) 2010 Lead-Based Paint Hazard Control Grant Program and Lead Hazard Reduction Demonstration Grant Program; Technical Correction

AGENCY: Office of Healthy Homes and Lead Hazard Control, HUD.

ACTION: Notice of technical correction.

SUMMARY: On September 2, 2010, HUD posted on www.Grants.gov its Notice of Funding Availability (NOFA) for HUD's FY2010 Lead-Based Paint Hazard Control Grant Program and Lead Hazard Reduction Demonstration Grant Program. Today's Federal Register publication announces that HUD has posted on www.Grants.gov to the respective application packages a technical correction that, for the Lead Hazard Reduction Demonstration Grant Program, corrects one of the forms, corrects Appendix A of the NOFA, extends the deadlines for affected eligible jurisdictions to submit a waiver request to reduce the statutory match and to submit an application. Specifically, HUD posted the 36-month benchmark form for the Lead-Based Paint Hazard Control Grant Program that should have been the 42-month benchmark form for the Lead Hazard Reduction Demonstration Grant Program; inadvertently omitted a number of jurisdictions that are eligible for the FY2010 Lead Hazard Reduction Demonstration Grant Program from part A of Appendix A, entitled "Cities, Towns, Counties, and States Having at Least One Place or County with 3,500 or More Occupied Rental Housing Units Built Before 1940, and Eligible States and Tribes;" and inadvertently included a number of jurisdictions that are ineligible for that grant program. The revised benchmark form and the revised Appendix A for the Lead Hazard Reduction Demonstration Grant Program can be downloaded from www.grants.gov, using the Catalog of Federal Domestic Assistance (CFDA) number for that program, 14.905.


DATES:

- A. For the Three Jurisdictions Now Eligible to Apply for Funding under the Lead Hazard Reduction Demonstration Program (CFDA number 14.905):
1. Match Waiver Request. The match waiver request is extended from 5:00 p.m. eastern time September 21, 2010 to 5:00 p.m. eastern time October 13, 2010.
 2. Deadline Date for Submission and Timely Receipt is extended from 11:59:59 p.m. eastern time October 15, 2010 to 11:59:59 p.m. eastern time November 4, 2010.
- B. For all Other Jurisdictions Eligible to Apply for Funding under the Lead Hazard Reduction Demonstration Program: The deadline for receipt of an application is extended from 11:59:59 p.m. eastern time October 15, 2010 to 11:59:59 p.m. eastern time October 22, 2010.
- C. For all jurisdictions eligible under the Lead-Based Paint Hazard Control Grant Program (CFDA number 14.900): There is no change to the deadline date for submission and timely

receipt. The original deadline for receipt of an application for that grant program remains at 11:59:59 p.m. eastern time October 15, 2010.
