SUPPLEMENTARY INFORMATION

On September 22, 2010, HUD posted on <u>www.Grants.gov</u> its Notice of Funding Availability (NOFA) for HUD's FY2010 Healthy Homes Production Grant Program. The NOFA made approximately \$10 million available, by the Consolidated Appropriations Act, 2010 (Pub. L. 111-117, approved December 16, 2009). The posted NOFA contained a single error that HUD is seeking to correct in several places. For the convenience of applicants, a revised version of the NOFA will be posted and can be found and downloaded from <u>www.Grants.gov</u>, using the Catalog of Federal Domestic Assistance (CFDA) number for the Healthy Homes Production Grant Program, 14.913.

Corrections.

On page 14, in section IV.B.1.b(3)(c), Form_HUD96013 was cited instead of
Form_HUD96016. As a result, section IV.B.1.b(3)(c) is corrected to read as follows:
"HUD96016_Need-Extent_of_the_Problem".

2. On page 17, in section V.A.2, "Rating Factor 2: Need/Extent of the Problem (15 Points Maximum)", Form_HUD96013 was cited instead of Form_HUD96016 in both instances. As a result, the first paragraph of section V.A.2 is corrected to read as follows:

"Applicants will be scored in this rating factor based on your documented need as evidenced by the submission of thorough, credible, and appropriate data and information. This factor addresses housing-related environmental health and safety hazards (including, but not limited to, mold, allergens, lead-based paint hazards, carbon monoxide, pesticides, home safety hazards) in your target area(s) that impact on your targeted group(s), in order to demonstrate the need for your proposed project activities. There must be a direct and substantial relationship between the proposed housing-related environmental health and safety hazard remediation activities and documented community needs. Applicants should ensure that the current residents of the target area, whose demographic characteristics constitute the data for this rating factor, are the individuals and families who should receive priority for the benefits of the funded programs and this should be addressed in the remainder of the application. Applicants must complete Form_HUD96016 to receive points for this rating factor. Multiple forms (one per target area jurisdiction) are permissible. Points will be awarded in this rating factor based on the characteristics of the target area, the number and percentage of pre-1978 housing units, the number and percentage of families with incomes at or below 80 percent of the Area Median Income as determined by HUD within the jurisdiction and/or target areas, the age and condition of housing, housing-based environmental health and safety hazard data, and other data that clearly demonstrate need for this funding. (NOTE: Data should be provided that is within the jurisdiction/target area – do not provide data that overlaps into another jurisdiction). Points will be awarded in this rating factor based on the information below. The applicant must complete Form_HUD96016 to receive points for this rating factor."

3. The NOFA's instruction package at <u>www.Grants.gov</u> included Form_HUD96013 instead of Form_HUD96016. As a result, the instruction package is revised to replace Form_HUD96013 with Form_HUD96016.
