# Focus on Fair Housing...

HUD has launched the HUD Language Line, a telephone language service pilot (to run through September 2012) that will offer live, one-on-one interpretation services in more than 175 languages. Accessible throughout the nation, the language line will help HUD staff communicate with people who have limited English proficiency (LEP) about HUD housing programs, services, and activities. "Access to government should not be determined by how well a person speaks English," said John Trasviña, HUD Assistant Secretary for Fair Housing and Equal Opportunity. "The **HUD** Language Line is another example of HUD's efforts to ensure that persons with limited English proficiency have equal access to HUD programs and services."

#### MORE FAIR HOUSING NEWS

The Department of Justice filed its largest residential fair lending settlement in history to resolve allegations that Countrywide Financial Corporation and its subsidiaries engaged in a widespread pattern or practice of discrimination against more than 200,000 African-American and Hispanic borrowers who qualified for loans, but were charged higher fees or placed into subprime loans from 2004 through 2008. The settlement provides \$335 million in compensation for victims of Countrywide's discrimination during a period when Countrywide originated millions of residential mortgage loans as one of the nation's largest single-family mortgage lenders. #### **MONEY MATTERS**

President Obama and Secretary Donovan are strong supporters of the Community Development Block Grant (CDBG) and HOME Investment Partnership (HOME) programs, and recognize their long and vital history of supporting critical neighborhood and housing needs. The tough economy has demanded some painful decisions, though, and we all must work with and through the challenges these decisions have created. Here they are in a nutshell: CDBG has been reduced by 11% and HOME has been reduced by 38% in the FY2012. HUD budget recently passed by Congress. FY 2012 also marks the first year the CDBG and HOME program funds will be allocated by a new formula calculation that relies on the Census Bureau's annual data source, the American Community Survey (ACS) and the 2010 Census data. The application of updated data to the allocation formulas, along with recent cuts to the CDBG and HOME programs, is expected to create a serious funding challenge for some communities. A table that provides an estimate of the combined effect of the new Census data and the FY 2012 budget on expected CDBG and HOME program funding for our grantees for FY 2012 is available. It's important to remember that these numbers are preliminary estimates only and are subject to revision in advance of the formal notification of HUD formula grant program allocations. HUD understands the potential for hardship the new census data combined with budget cuts represents, and we are taking steps to provide increased technical assistance to help Region III communities use their CDBG dollars in the areas of greatest need. Assistant Secretary for Community Planning and Development Mercedes Márquez has sent all formula grantees a message concerning these changes saying, "We are committed to doing everything we can to support you in this period of transition." #### **CONGRATULATIONS ARE IN ORDER**

HUD announced the selection of the German Marshall Fund (GMF) partnership as the recipient of \$2.5 million award to manage the Strong Cities, Strong Communities (SC2) fellowship program. The <u>partnership</u> is comprised of the German Marshall Fund, Cleveland State University, and the Metropolitan Institute at Virginia Tech. SC2 is a pilot program focused on retooling and rebuilding the capacity of cities facing long-term economic challenges (often known as cities in transition or legacy cities), which have been identified as:

Region III Homeless Intervention programs received \$168,245,855 in <u>FY 2011 Continuum of Care Renewal funding</u>. This funding will allow continuation of desperately needed housing and services for families, individuals and veterans who are homeless.

The trustees administering Mary Ludlow's legacy donated \$1 million to the <a href="Hampton Roads Community Foundation">Hampton Roads Community Foundation</a> to create a permanent endowment to benefit ForKids. The Norfolk-based nonprofit started in 1988 as an emergency homeless shelter. Over the years it has added other housing and programs to assist homeless families, and currently helps 175 children and parents in Norfolk and Suffolk create self-sufficient, happy lives.

News from FHA: In an effort to continue stabilizing home values and improve conditions in communities experiencing high foreclosure activity, Acting Federal Housing Administration (FHA) Commissioner Carol J. Galante will extend FHA's temporary waiver of the anti-flipping regulations. The new extension will permit buyers to continue to use FHA-insured financing to purchase HUD-owned properties, bank-owned properties, or properties resold through private sales. It will allow homes to resell as quickly as possible, helping to

stabilize real estate prices and to revitalize neighborhoods and communities. The extension is effective through December 31, 2012, unless otherwise extended or withdrawn by FHA.

A drop in homelessness has been noted by the Obama administration. On a single night in January 2011, HUD states, 636,017 people were homeless, a reduction of 2.1% from January 2010 and 5.3% since 2007. The study also shows that homelessness among veterans dropped by 12% over the same period, and indicates that the effort to implement "Opening Doors," the Federal strategic plan whose goal is to end homeless among vets by 2014, and chronic homelessness by 2019, is having measurable results. The <u>final</u> "Definition of Homeless" rule was published in the <u>Federal Register</u>. This final rule will apply to ESG recipients, as well as Supportive Housing Program and Shelter + Care grantees that receive funding through the FY 2011 Continuum of Care Competition, effective January 4, 2012. # **HUD EASTERN PENNSYLVANIA/ REGIONAL OFFICE**

The residents of Paschall Village in Philadelphia, PA are enjoying the latest energy efficient systems in their homes, and that will add up to real energy savings as winter's cold creeps into the Mid-Atlantic Region. The green development is complete with geothermal heating and cooling, a solar domestic hot water system and a rainwater harvesting irrigation system. HUD invested \$46.3 million in this Energy Star certified, 100 unit development that includes a computer lab and community space. HUD's Acting Deputy Regional Administrator Richard Ott was on hand to dedicate Paschall Village. Read the story <a href="here">here</a>.

The Pennsylvania Association of Housing and Redevelopment Agencies posed some questions to HUD Regional Administrator Jane C. W. The HUD has approved a \$1.3 million Section 108 loan guarantee to Berks County to rehabilitate the Second Street area of the Borough of Hamburg. The funds will be used to acquire property to build a pedestrian promenade that will include walking and bike trails, sitting areas and open space. The project also includes street and road improvements throughout the Second Street redevelopment area and construction of public parking. HUD's Section 108 Loan Guarantee Assistance Program enables local governments to borrow money at reduced interest rates to promote economic development, stimulate job growth and improve public facilities. Erie County was one of the 29 recipients of a 2011 Sustainable Communities Regional Planning Grant. Jane Miller, Field Office Director of the Pittsburgh HUD Office, presented Barry Grossman, County Executive, and several or Erie County's core partners with a Regional Planning Grant in the amount of \$1.8 million.
