#### A Message from the Regional Administrator

Dear Friends,

June is Homeownership Month, and HUD continues to work with our partners to keep the American Dream alive. President Obama has a plan to help borrowers who are current on their payments, but underwater on their mortgages, to refinance. The \$25 billion mortgage settlement will certainly provide some relief for struggling homeowners, as Region III states receive \$2.6 billion to help support housing counseling and foreclosure prevention. Each state is deciding how to best implement its share of the settlement. States may also negotiate additional settlements or take other action if they think it necessary. Meanwhile, a different mortgage settlement allows borrowers to request an independent foreclosure review if they believe their homes were unfairly foreclosed in 2010 or 2011. The borrowers are eligible for the review to determine if they suffered financial injury as a result of errors during the foreclosure process, and whether they may be eligible to receive compensation. Servicers sent letters informing 4 million borrowers of their rights to reviews, but there is concern that the letters were mistaken for "scam-mail," and were left unopened. The good news is that borrowers can request a review online by clicking here. All requests for independent foreclosure reviews must be postmarked or submitted on line by July 31. Please share this important information with your family, friends and colleagues. President Obama, and everyone at HUD, is fully committed to "Keeping the Dream Alive."

#### SETTLEMENT SAVVY...

You may be interested in the HUD and Attorney Generals' settlement with major mortgage servicers, which addresses foreclosure processing violations by the nation's largest mortgage servicers, and provides substantial and immediate financial relief to homeowners. Three areas of assistance are targeted: homeowners who need loan modifications now; borrowers who are current, but underwater; and borrowers who lost their homes to foreclosure. The settlement also establishes new homeowner protections for the future -- forcing the biggest banks to clean up their acts and fix the problems that led to so much devastation in your communities. Here is an information page to help you find out if you or someone you know may be eligible to participate in the settlement.

The \$25 billion mortgage settlement will provide some desperately needed relief for struggling homeowners. The participating states (all of the states in Region III have signed the settlement) will receive \$2.6 billion to be used for housing counseling and other foreclosure prevention efforts. Maryland is the first state to announce how it plans to use its share of the settlement money. The landmark foreclosure settlement between the state and the nation's five largest lenders is expected to bring significant new resources for foreclosure prevention counseling to Maryland. Maryland Attorney General Douglas Gansler established a work group, including Maryland Department of Housing and Community Development staff, to develop the best plan for using those resources. In addition, the attorney general's office expects to conduct from 20 to 30 workshops across the state this summer to help homeowners, housing counselors and the public understand the terms of the settlement and what to expect. There will be three in Baltimore, beginning with a workshop with US Representative Elijah Cummings on June 16. There is more help in the works: If you're a responsible homeowner and are current on your mortgage payments but would like to refinance for a lower payment, help could be on the way. President Obama has proposed a plan that would allow underwater homeowners to refinance at historically low rates. The plan is expected to save homeowners who are current on their payments an average of \$3,000 per year, giving borrowers the chance to rebuild equity in their homes. In this installment of the <u>White House White Board</u>, Brian Deese, Deputy Director of the National Economic Council, explains how the President's plan would make it much easier for millions of American homeowners to refinance their mortgage and save hundreds of dollars every month.

#### SUSTAINABILITY PARTNERS AT WORK ...



The matrix highlights 10 proven and affordable green building technologies organized into four categories: Building Envelope, HVAC, Management and Use, and Water. #### TOTALLY RAD ....

HUD's new Rental Assistance Demonstration (RAD) is designed to test new preservation tools for the HUD-assisted housing stock by allowing:

- Public Housing and Moderate Rehabilitation (Mod Rehab) properties to convert, under a competition limited to 60,000 units, to long-term Section 8 rental assistance contracts; and
- Rent Supplement (Rent Supp), Rental Assistance Payment (RAP), and Mod Rehab properties, upon contract expiration or termination, to convert tenant-based vouchers, either in their current form as Enhanced Vouchers or Tenant Protection Vouchers, to project-based vouchers.

<u>New ADA Design Standards</u>: On March 15 the 2010 Americans with Disabilities Act (ADA) Standards for Accessible Design went into effect. The standards set new requirements for fixed or built-in elements in facilities such as swimming pools and play areas. The rules also clarify and refine issues that have arisen over the past 20 years, including service animals, reach ranges, toilet room dimensions, and accessible routes. Specifically:

- The definition of "service animal" is now limited to a dog that is individually trained to do work or perform tasks for an individual with a disability. The task(s) performed by the dog must be directly related to the person's disability.
- Access to parking, routes to the playground, playground equipment and amenities (picnic tables and
- restrooms) is addressed.
- Playground equipment is now required to be accessible.
- Swimming pools, wading pools, and spas (pools) must be accessible.
- Newly constructed or altered places of public accommodation, commercial facilities and state and local government facilities are required to comply with the ADA Standards.

# NEWS YOU CAN USE ...

When Secretary Donovan established HUD's Strategic Plan, among the Department's top goals was to transform how HUD does business. It was really quite simple: fix what's broken and improve what needed improving. The Office of Community Planning and Development (CPD) has launched an overhaul of the planning process that 1,200 cities, counties and states are required to satisfy as a condition of receiving billions of dollars in annual block grant assistance. The eCon Planning Suite: Consolidated Plan and IDIS will allow HUD grantees to submit their Consolidated Plan using the Consolidated Plan template in IDIS OnLine. These new tools will help local planners approach their jobs in a smart way, ensuring increasingly scarce federal dollars are targeted to where they are needed most. It is estimated HUD's new approach will save communities approximately 65,000 staff hours each year and will save HUD staff 30-40 hours per Consolidated Plan.

Housing ex-offenders: Each year, more than a half million people are released from prisons in the U.S., and an additional 7 million are released from jails. Research shows that ex-offenders who do not find stable housing in the community are more likely to recidivate than those who do, yet people returning to their communities from prison often face significant barriers to obtaining housing. Studies have also found that the majority of people released from prison intend to return to their families, some of whom may live in assisted housing. The Department is asking owners of HUD-assisted properties to seek a balance between allowing ex-offenders to reunite with families that live in HUD subsidized housing, and ensuring the safety of all residents of its programs. Accordingly, the Department encourages owners of HUD-assisted properties to develop policies and procedures that allow ex-offenders to rejoin the community to the extent that this balance can be maintained. When screening family behavior and suitability for tenancy, owners may consider all relevant information, including factors that indicate a reasonable probability of favorable future conduct. For example, evidence of rehabilitation

and evidence of the applicant family's participation in or willingness to participate in social services such as counseling programs. Read more in the <u>Philadelphia Multifamily Housing HUB News</u>.

HUD has released two reports on the impact of HUD-approved housing counseling for those families who purchase their first homes and those struggling to prevent foreclosure. In both studies, HUD found housing counseling significantly improved the likelihood homeowners remained in their homes. # WHAT'S HAPPENING AROUND REGION III...

# HUD EASTERN PENNSYLVANIA/ REGIONAL OFFICE

HUD Secretary Shaun Donovan gave the keynote address to the Federal Reserve Bank of Philadelphia's Fifth Biennial Reinventing Older Communities conference in Philadelphia on May 10. The conference focused on how government, non-profit, academic, philanthropic, and private-sector partners can support economic development strategies to reinvent older communities and build more resilient cities – large, medium, and small – across the United States. The Secretary highlighted HUD and the Administration's work to strengthen the housing market and create jobs. He talked extensively about the <u>Strong Cities</u>, <u>Strong Communities</u> program as a key effort by the Obama Administration to help local governments strengthen their capacity, better utilize existing resources, and change how the federal government partners with communities to help cut through red tape and rebuild economies. Secretary Donovan noted that SC2 emphasizes the critical role of locally driven decisionmaking and priority setting. This local leadership allows federal agency representatives on the SC2 Community Solutions Teams to work side-by-side with city government staff and other community partners to address locally identified priorities and break down federal government barriers. As a part of the conference, attendees enjoyed a bus tour (see the pictures below) to visit Chester and were able to witness first-hand the potential of that small city to rebuild, especially when the right partners are committed to the effort. The shared vision and development of partnering potential is what makes the SC2 initiative dynamic, and is what made the week in Philadelphia and Chester memorable.



The HUD Region III Office is engaged in the <u>Strong Cities, Strong Communities</u> (SC2) pilot program in Chester, PA, which will continue for another year. Chester is a city with numerous challenges and, as the SC2 team is learning, many assets that can be leveraged; such as local "anchor" institution Widener University. Located just 13 miles south of Philadelphia, the City of Chester is working closely with Widener, and with the Institute for Economic Development and the Crozer-Chester Medical Center, to strengthen home ownership by encouraging employers to provide cash incentives to workers who settle in Chester, with the City contributing money to cover down payment costs. On May 30, the partnering federal agencies, including HUD, signed a memorandum of understanding with Chester Mayor Linder to continue working together to strengthen economic and community development in the city.

On May 10 the HUD Delaware participated in a Sustainable Communities event sponsored by the <u>Delaware</u> <u>Department of Transportation</u> (DEDOT). These veterans had the opportunity to sit down with 20 landlords who have housing units already approved and pre-inspected by DCHA. Most of the veterans will move into their new housing this week. Left, Vietnam Veteran Helen Sullivan received a voucher and spent time at the event reviewing the information about available units that the landlords brought. Ms. Sullivan decided to visit some of the units before she made up her mind on which would be her future home.

The <u>Affordable Housing Conference of Montgomery County</u> was held May 7. Secretary Shaun Donovan was the keynote speaker, and Regional Administrator Jane C. W. Vincent hosted a panel on veterans housing issues and addressed the lunch time press conference. A recent study released at the conference showed a waiting list in excess of 115,000 in the DC Metropolitan area for public housing and vouchers.

Homeless and at-risk veterans now have 24 hour access to help. The Washington DC VA Medical Center opened the doors to its new <u>Community Resource and Referral Center</u> (CRRC) May 9. The new CRRC is the first of its kind in the metropolitan DC area and will serve as a community hub to combat homelessness among veterans. The CRRC will centralize services such as healthcare, housing, employment, benefits and education—into a collaborative center located in the heart of the community.
