#### A Message from the Regional Administrator

Dear Friends,

With rising temperatures and record-breaking heat forecast throughout the region this month, more people are seeking relief out of the sunlight and in their homes. With concern for tenants who are spending more time indoors, HUD sees our continuing effort to provide safe and healthy affordable housing as more important than ever. With the goal of healthy homes in mind, HUD's Office of Healthy Homes and Lead Hazard Control, along with the USDepartment of Health and Human Services and other health advocates, has released a set of toolkits to help provide a smoke-free environment in subsidized federal housing. These toolkits, created for owners, managers and residents, offer information on the health effects of smoking and secondhand smoke, as well as "how-to" brochures and information about housing authorities with smoke-free policies. It's a known fact that smokers are two to six times more likely to develop heart disease when compared to nonsmokers. Additionally, secondhand smoke increases one's risk of heart disease and childhood illnesses. Feel free to share the toolkits with your local housing authority and any others who may benefit as we work toward creating healthy havens from the summer heat!

# SETTLEMENT SAVVY... UPDATES FROM THE STATES

In Virginia: Nearly 1,000 homeowners in Prince William County and the cities of Manassas and Manassas Park have been identified as eligible for assistance under the National Mortgage Settlement announced early this year. The <u>announcements</u> about how the housing settlement will affect Prince William County came at a community meeting sponsored by <u>Virginians Organized for Interfaith Community Engagement</u> (VOICE).

In Maryland: The <u>Maryland Department of Housing and Community Development</u> has issued a Request For Proposals for the <u>Maryland Housing Counseling Fund</u>, and for the Mortgage Loan Servicing Practices Settlement Fund on behalf of the <u>Maryland Office of the Attorney General</u>. In Pennsylvania: The <u>Homeowners' Emergency Mortgage Assistance Program</u> (HEMAP) will again be funded following Gov. Tom Corbett's signing of <u>Senate Bill 1433</u>, which establishes a trust fund to use the more than \$60 million allocated to Pennsylvania as part of the \$25 billion joint state-federal mortgage settlement with the country's five largest loan servicers.

The USD epartment of Veterans Affairs (VA) joined JBJSoul Foundation Chairman, Jon Bon Jovi, to announce the five finalists of Project REACH (Real-time Electronic Access for Caregivers and the Homeless) during the Health Data Initiative Forum in Washington, D.C., sponsored by the USD epartment of Health and Human Services' (HHS). Two of the finalists, Binary Group of Arlington, VA and Qbase of Reston, VA are in Region III. Read more about the Project REACH challenge here.

The Philadelphia Housing Authority and the Philadelphia Veterans Affairs Medical Center will receive \$544,757 of the additional \$25 million announced by HUD Secretary Shaun Donovan and VA Secretary Eric K. Shinseki to supply housing and case management for homeless veterans. This funding is part of a total \$75 million the Obama Administration is investing in HUD's <u>Veterans Affairs Supportive Housing Program (HUD-VASH</u>), this year to provide permanent housing with case management and other supportive services for homeless veterans who might otherwise be living on the streets. Housing Counseling Services of Maryland and the Housing Alliance of Pennsylvania are two of the fifteen nonprofit agencies selected to receive funding through HUD's new Tenant Resource Network (TRN), an effort to help low-income tenants receiving Section 8 project-based rental assistance and to preserve affordable housing. Grants will be used to assist, inform, educate and engage tenants who live in Section 8-assisted properties that are at risk of losing affordability. Read more about TRN <u>here</u>.

Homeless Management Information Systems Technical Assistance awards were made to five providers, three of whom are from Region III. ICF International (VA) will receive \$1,782,000, the National Center on Family Homelessness (VA) will receive \$877,800, and Cloudburst Consulting Group (MD) will receive \$1,482,000 to

provide technical assistance with data collection, reporting and research, including developing the Annual Homeless Assessment Report (AHAR). Read the Federal Register announcement <u>here</u>.

One CPD and Core Curriculum Technical Assistance awards were made to 18 providers, eight of whom are in Region III. The awards will be used to conduct technical assistance and capacity building activities for recipients, including state and local governments and non-profit organizations receiving funds from HUD's Office of Community Planning and Development (CPD). The awardees will also develop, deliver and enhance Core Curricula in the areas of Development Finance, Environmental Review and Compliance, Asset Management and Preservation of HUD-Assisted Projects, and Construction and Rehabilitation Management. #### New Mortgagee Letters:

2012-10 – discusses FHA rescission of the new guidance on policies concerning Disputed Accounts and Collection Accounts discussed in Mortgagee Letter (ML) 2012-3, which was to become effective July 1, 2012. 2012-11- provides changes relating to title approval at conveyance.

2012-12 - clarifies that FHA policy does not exempt mortgagees from adhering to state and local laws relating to the protection and preservation of properties that were secured by an FHA insured mortgage.

On June 7, the New River Center for Energy Research and Training, a division of Christiansburg, VA based Community Housing Partners, became the first U.S. Department of Energy weatherization training center in the nation to obtain Interstate Renewable Energy Council Institute for Sustainable Power Quality Training Program accreditation. This accreditation allows NRCERT to teach its national Retrofit Installer curriculum for weatherization and home performance professionals. # NEWS YOU CAN USE ...

During the Annual meeting of the U.S. Conference of Mayors, HUD Acting Assistant Secretary for Policy Development and Research Erika Poethig and Acting Assistant Secretary of Commerce for Economic Development Matt Erskine announced that the <u>Strong Cities</u>, <u>Strong Communities</u> <u>Initiative (SC2)</u> will allocate \$11 million in grants to help economically challenged municipalities create long term economic development plans, and will fund the establishment of the SC2 National Resource Network. The U.S. Economic Development Administration will launch a groundbreaking \$6 million SC2 Challenge to help economically challenged cities leverage innovative strategies to spur local economic and job growth. The application deadline for the challenge is July 23. <u>Click</u> here for more information about the competition.

HHS has created a new organization, the Administration for Community Living (ACL) to increase access to community supports and full participation, while focusing attention and resources on the unique needs of older Americans and people with disabilities. The ACL will incorporate the Administration on Aging, the Office on Disability and the Administration on Developmental Disabilities into a single agency, with enhanced policy and program support for cross-cutting initiatives and efforts focused on the unique needs of children with developmental disabilities, adults with physical disabilities, and seniors, including seniors with Alzheimer's. HHS's Centers for Medicare and Medicaid Services (CMS) has issued new guidance relating to implementation of the Supreme Court's decision in Olmstead v. L.C. More guidance will be issued in the near future, but meanwhile, the CMS bulletin (click <u>here</u>) provides a helpful overview of the way HUD programs may be used to support deinstitutionalization efforts.

The US Small Business Administration (SBA) has announced the Patriot Express Pilot Loan Initiative for veterans and members of the military community who want to start or expand small businesses. The SBA and partners are offering additional counseling and training with this loan initiative, which will make it more accessible and easy to use. Patriot Express loans feature the SBA's lowest interest rates for business loans, generally 2.25 percent to 4.75 percent over prime depending upon the size and maturity of the loan. Your local <u>SBA district office</u> will have a listing of Patriot Express lenders in your area.

In light of last summer's surprising earthquake, Virginia, the District of Columbia and Maryland are in discussions with FEMA and other southeastern states (Georgia, South Carolina, North Carolina) to be first-time participants in an earthquake drill. "ShakeOut" drills have been held in the past in California and in the central U.S., but this is the first time the southeastern states have expressed interest in joining a national effort. The "ShakeOut" date is scheduled for October 18 at 10:18 am. The time is the same regardless of the time zone a state or country is in, to give the effect of a rolling drill, from Guam to Hawaii to California to central U.S. to the southeastern U.S. For information on earthquake drills, click <u>here</u>.

# WHAT'S HAPPENING AROUND REGION III...

#### <u>HUD EASTERN PENNSYLVANIA/ REGIONAL OFFICE</u>



HUD Deputy Secretary Maurice Jones visited Chester and Philadelphia PA to see HUD's impact on the people, partners and places that benefit from our programs. Chester is one of six SC2 (Strong Cities, Strong Communities) that HUD and other federal agencies are working with to improve economic and community development. The Deputy stopped by the community garden at Bennet Homes in Chester and was warmly greeted by volunteers of all ages, who were eager to show him the abundance of their garden. the work that Sister Mary Scullion of Project H.O.M.E is doing to help residents of the community move toward greater economic independence by increasing educational and employment opportunities. The Honickman Learning Center & Comcast Technology Labs help adults and students get the skills and training they need to succeed. Pictured (right) with the Deputy Secretary is Sister Mary Scullion and Janet Moody. Sister Mary Scullion also showed off Rowan Homes and St. Elizabeth's Recovery Residence, which provide safe, secure housing for families and individuals who were homeless.



In North Philadelphia, Paseo Verde, a new transit-oriented development project that broke ground in April, has the potential to become a model for green revitalization. Paseo Verde, which translates as "Green Way" in Spanish, is designed to be a sustainable, mixed-use development that will offer neighborhood residents and Temple University students and employees a place to live, shop, and access community services. Scheduled for completion in Spring 2013, the project will consist of <u>120 rental units</u> (67 market-rate and 53 affordable units) for low- and moderate-income families that are expected to benefit from greater public transit access. In addition, Paseo Verde will apply for certification through LEED for Homes and Neighborhood Development. #### HUD MARYLAND

The Maryland Mortgage Program has announced a reduced interest rate of 2.875% (APR 3.675%) in targeted areas around the state, including the entire jurisdiction of Baltimore City, in order to increase homeownership. In June, Mayor Rawlings-Blake announced the launch an additional \$500,000 for the <u>Vacants to Value</u> Homeownership Program, making a total of \$1 million available to for the first 100 buyers of "Vacants to Value" eligible homes. <u>Click here</u> to read about other Baltimore City homeownership programs.

Based on Governor Martin O'Malley's recognition of the need to bring "efficiency and transparency to the mediation process," Hope LoanPort® (HLP), has announced the launch of the Maryland Mediation Portal (Portal) as the first statewide mediation portal in the country. Historic statues have been removed from Baltimore Housing's <u>McCulloh Homes</u> public housing development for a much-needed facelift, and residents and community leaders were all present to see the event. After more than 70 years' exposure to the elements, the fragile works of art had deteriorated. In an effort led by residents Monique Yates and June Johnson, the agency was awarded \$80,000 in preservation funding from the <u>Baltimore City</u> <u>Commission for Historical and Architectural Preservation</u> (CHAP), for the replication of the statues designed by Henry Berge. The time worn statues have been carefully removed and transported to the Steve Tatti Fine Arts Conservator studio where replication work will take place over the approximately six months.

The seniors were the first graduating class of the <u>Connected Living</u> program, which provides training and offers seniors living at the community access to technology, programming and support. The goal of the program is to help seniors stay connected and engaged, narrowing the digital divide that isolates many senior citizens. Connected Living launched the Garfield Terrace program on April 10 with a group of twenty-four residents, providing them with access to computers and helping them to live richer, more connected lives through the use of technology. The graduation ceremony included a welcome address given by D.C.

#### HUD VIRGINIA

A new research tool recently added to Housing Virginia's <u>SOURCEBOOK</u> provides information on the combined costs of housing and commuting for each locality in Virginia. This information shows that a modest income family can spend over half of its income on commuting and housing costs. The national standard for combined housing and commuting costs is 34% of household income. <u>Read more here.</u>

The Virginia Department of Veterans Services and more than 40 employers joined to announce the "Virginia Values Veterans (V3) initiative to help recruit and retain military veterans. Representing companies ranging in size from 20 employees up to corporations such as Anthem, Dominion Resources and Amazon.com, hiring managers and senior executives had two essential qualifications in common: they are all hiring in Virginia and are committed to hiring military veterans. The V3 initiative will work to develop a Commonwealth-wide approach to reducing veteran unemployment, and represents an economic investment to re-capitalize Virginia's workforce.
