A MESSAGE FROM THE REGIONAL ADMINISTRATOR

For the past month, it has been my pleasure to travel throughout the Mid-Atlantic region to meet with community and nonprofit leaders, housing counselors and lenders, elected officials and concerned citizens. The topic? Helping homeowners keep their homes.

We commend the many individuals who have played a critical role in the Obama Administration's work to help communities recover from the housing crisis. Together, we have made real progress. Because we have provided responsible families opportunities to stay in their homes, 5.4 million modifications have been started in the last three years and foreclosure notices are half what they were in early 2009. By making targeted neighborhood stabilization investments, we have seen vacancies fall and home prices rise.

To be sure, we still have more to do. But with housing construction growing faster than any time since 2008--and home price gains helping 700,000 homeowners get above water in just the first three months of this year--our housing market appears to have turned a corner.

Along with the recent bipartisan \$25 billion national servicing settlement—\$210 million for the region alone—we have the momentum we need to continue that progress as we launch the most ambitious mortgage relief effort in history, and provide homeowners with billions that can be used for housing counseling, legal aid and other anti-foreclosure efforts.

At a time when we have had to scratch and claw for \$45 million in housing counseling in Washington--resources we



know prevent foreclosures--these funds arrived not a moment too soon. Even still, there are still many families that are still struggling with their mortgages--we heard that message loud and clear at each gathering we attended.

In Richmond, HUD Chief of Staff Laurel Blatchford joined the Virginia Field Office team for the discussion. According to the Virginia Housing Development Authority, home prices continue to be negatively impacted by both higher for-sale inventories and growing distressed inventories. Home values in the Richmond Metro area remain well below their peak—a negative 18 percent—causing potential sellers to hold off marketing their properties until values appreciate. And, potential buyers continue to face challenges obtaining mortgage credit and are competing with investor "all-cash" purchasers. Housing counselors in attendance expressed the need for more educational outreach and the use of social media to help get the word out about options available to struggling homeowners.



At an event hosted in New Castle County, officials cited that Delaware averaged about 2,000 foreclosures per year before the mortgage crisis. In 2010 and 2011, Delaware State Housing Authority (DHSA) estimated foreclosure numbers could reach 6,000 annually. The important role of housing counselors—and the added resources the mortgage settlement will offer—was expressed time and time again. Quarterly servicer events hosted by the Attorney General's Office and the DSHA will provide homeowners in each county with the chance to meet face to face with banking representatives and housing counselors hopefully preventing more foreclosures. Homeowner Dawn Pyle provided a personal testimony to the importance of housing counseling she received from the DSHA and YWCA Delaware. Pictured second from right with Matt Heckles (DHSA),

In the District of Columbia, the message was much the same. Homeowners who seek assistance through housing counselors have better outcomes. Much of the discussion centered around two key questions. How do we get the message to homeowners? How do we get more residents who are in danger of foreclosure to seek housing counseling? An acknowledgement that for many, the ultimate goal in life is to own a home. And that in this day and age, that lifelong goal for many may be in jeopardy because of circumstances beyond their control.

In communities like Alexandria, finding affordable housing can be as challenging as keeping it. A panel that included lenders, housing counselors and legal advisors offered advice about when it makes sense to refinance as well as why condominium owners should become active in their condo associations. Panelists spoke of options that are available to avoid foreclosure including short sales, deed in lieu and refinancing—and that housing counseling is free—to anyone no matter their income level. And, individuals should always seek HUD-approved housing counseling agencies.



In Baltimore, participants engaged in robust dialogue regarding the President's refinancing proposals; identifying solutionfocused recommendations. Those attending agree that increasing funding for housing counseling, linking energy- efficiency to foreclosure prevention, and identifying specific strategies to address the unique of seniors both foreclosure prevention and intervention would be a few positive forward-moving tactics. The roundtable concluded by all enthusiastically agreed to continuing meeting to further discuss challenges, opportunities and best practices that can respond to the foreclosure challenges experienced by Baltimore City residents.

So, what can each and every one of us do to help? Learn what is available to homeowners.

WHA Opens First Smoke Free Complex

On Aug. 17, the Wilmington Housing Authority (WHA) hosted a standing-room only crowd at the grand re-opening of the 24-unit Kennedy Apartments. The \$1.5 million renovation received substantial support through HUD Capital Funds and the Neighborhood Stabilization Program. The development is WHA's first totally "smoke free" building. To maintain air quality, all residents are required to sign non-smoking lease addendums. Residents are also required to participate in family self-sufficiency programs that focus on preparing them for homeownership. HUD Region III Administrator Jane C.W. Vincent and Nemours/Alfred I. duPont Hospital for Children's Timothy Cox spoke convincingly about the potential health issues caused by smoking and secondhand smoke. The Mayor of Wilmington and the Executive Director of the WHA both spoke about the historic background of the Kennedy Apartments and the surrounding neighborhood.

HOME-funded Housing Opportunity Funds Renovation in Alexandria On Aug. 28, Community Lodgings, Inc. (CLI) will celebrate the kick-off of a major renovation of its property at 612 Notabene Drive. The City of Alexandria provided a \$300,000 loan to CLI in support of this renovation. CLI is working with Pulte Homes and HomeAid Northern Virginia to complete the renovations which include new windows and doors, HVAC system replacement, an electrical and plumbing upgrade, a new roof, bathroom and kitchen upgrades (including new appliances, fixtures, and cabinets), common area updates and new flooring. HomeAid builds and renovates homeless shelters, transitional houses, food banks, medical clinics, counseling centers, and other facilities that help homeless people gain stability and a roof over their heads.

CLI is a local non-profit organization, established in 1987, to preserve affordable housing, provide transitional housing for the homeless, and help families become self-sufficient through counseling and supportive services programs. CLI currently operates 14 units of transitional shelter for the homeless and 30 units of affordable housing.

Union Rowe Renovation Increases Energy Efficiency— Residents Save \$'s

The recent renovations at Union Rowe, 72 affordable units in West Baltimore, have improved the property's energy performance by 40 percent. AHC Greater Baltimore installed Energy Star appliances, new energy efficient water heaters and HVAC systems, all new windows with Low E glass (which controls the heat transfer through window panes) and other energy improvement methods to reduce the amount of water, gas and electricity used, resulting in a significant savings for residents. The Maryland Department of Housing and Community Development granted \$180,000 for the energy improvements through its Multifamily Energy Efficient Housing Assistance (MEEHA) Program. DHCD Funding Homeless Shelter for Female Veterans in Western Maryland

Work is beginning on the conversion of a former downtown office building into a shelter for homeless veterans, particularly women who served in Afghanistan and Iraq. The 27-bed Way Station Welcome Home Veterans project, made possible through a \$900,000 grant from Maryland's Department of Housing and Community Development (DHCD), will treat veterans with mental illness, substance abuse problems and Post Traumatic Stress Disorder. The office building previously was used by an affiliate of Way Station Inc., the nonprofit mental health organization with facilities in Carroll, Frederick, Howard and Washington counties. Funding for the \$3.3 million project included the grant from DHCD's Shelter and Transitional Housing and Facilities Grant Program and support from the Maryland Department of Mental Health and the U.S. Veterans Administration. The project comes amid growing concern about the difficulties - emotional and financial - that returning veterans face in Maryland and throughout the country. Female veterans make up about eight percent of all veterans nationwide, compared to four percent in 1990, the Associated Press reported last spring. There are an estimated 3,200 homeless female veterans across the country, many with young children and many suffering the same stresses from serving in a frontless combat zone as their male counterparts.

Baltimore Housing's Development Wins Housing Achievement Award

Baltimore Housing Commissioner Paul T. Graziano recently announced that Broadway Homes received the 2012 Housing Association of Nonprofit Developers (HAND) Innovation Award. HAND presents awards each year to recognize best practices in affordable housing projects, programs and organizations in the greater Washington region. In this one of a kind undertaking, HABC procured Homes for America, a non-profit housing corporation, to acquire, renovate and manage 58 homes. The goal of the Broadway Homes Project was to create a variety of public housing opportunities throughout the Baltimore region for low-income families. The properties are located in stable, attractive, neighborhoods in Baltimore City and neighboring Baltimore, Anne Arundel, Harford, and Howard counties with good access to transportation and high quality schools. The Broadway Homes Project was completed in 2011. All of the single-family detached and attached energy efficient homes serve former residents of the Baltimore City public housing program. HUD Approves \$1.5 Million Loan Guarantee to Reading *Financing to Support Downtown Arts District*

HUD approved a \$1.5 million loan guarantee to the City of Reading to assist with converting several properties within the Downtown Arts District into mixed-use developments consisting of retail space and housing for low- and moderate-income persons. HUD's loan guarantee, along with the Brownfields Economic Development Initiative (BEDI) grant in the amount of \$750,000, will assist in the creation of 25 low-and moderate-income rental units; seven (7) low- and moderate-income homeownership units, and 20,000 square feet of commercial/retail space. In addition, the project will result in the creation of 28 full-time equivalent jobs.

HUD's Section 108 Loan Guarantee Assistance Program enables local governments to borrow money from private investors at reduced interest rates to promote economic development, stimulate job growth and improve public facilities. Such public investment is often needed to inspire private contributions, to provide seed money, or to simply boost confidence that many private firms and individuals need to invest in distressed areas.

The BEDI is a key competitive grant program that HUD administers to stimulate and promote economic and community development. BEDI is designed to assist cities with the redevelopment of abandoned, idled and underused industrial and commercial facilities where expansion and redevelopment is burdened by real or potential environmental contamination. The City of Reading requested HUD's loan guarantee to revitalize the distressed areas surrounding GoggleWorks I and GoggleWorks II, which are multi-purpose arts centers that were financed in part with previous Section 108 funds and BEDI grant funds.

All will exceed Energy Star standards and will include advanced features, such as dual-flush toilets and energy recovery ventilators.

PENNSYLVANIA – WESTERN REGION Homelessness: Another Kind of Battlefield HUD Pittsburgh joins "STAND DOWN 2012" For the fifth straight year, VA Pittsburgh co-r formerly homeless veterans and their familie

For the fifth straight year, VA Pittsburgh co-hosted a Stand Down for current and formerly homeless veterans and their families. "Stand Down" is a military term referring to fresh troops taking care of exhausted combat troops by moving them to a safe and secure place. In Stand Down, soldiers recuperate to help them face future challenges.

Held on Aug. 11 at the Shepherd's Heart Fellowship in Pittsburgh, more than 300 veterans participated in the event, which provided breakfast, lunch, haircuts, live music and other entertainment. More importantly, Stand Down provided a link to resources and services in hopes of ending homelessness among veterans.

HUD Pittsburgh joined forces with a cadre of concerned service providers that included Veterans Leadership Program, Operation Safety Net, CareerLink, VA Healthcare for Homeless Veterans, Disabled American Veterans, amongst others. A circle of care and compassion was drawn around the homeless veterans present, while an atmosphere of respect and near reverence pervaded among the many service providers. "This was our duty," noted Jane Miller, HUD Pittsburgh Field Office Director as she counseled an attendee. "They had already done theirs."

Recovery Plan to Be Developed Following Derecho

On June 29, West Virginia experienced a derecho that caused massive damage throughout the state. This widespread, long lived, straight-line windstorm and severe thunderstorms caused more than two thirds of West Virginia residents to lose their power from one to two weeks. In addition, the derecho caused major public and private infrastructural damage from electrical transmission towers, loss of businesses and homes. In July 2012, West Virginia received a Presidential Federal Disaster Declaration. According to filings with the state Public Service Commission, West Virginia's

largest power providers spent a combined \$172 million on repairs and restoring service following the windstorm and subsequent storms that left three people dead and more than 680,000 customers without electricity.

On Aug. 9, in Charleston, West Virginia, a Joint Interagency Meeting of federal, state and private groups held a planning meeting to assist in recovery efforts associated with the derecho. The West Virginia Field Office participated in the meeting to assist in developing a strategic plan of recovery that will address residential and business economic losses, funding opportunities and supportive services.
