A MESSAGE FROM THE REGIONAL ADMINISTRATOR



On April 11, 1968 President Lyndon B. Johnson signed the Fair Housing Act into law prohibiting discrimination in the sale or rental of housing based on race, color, sex, religion, national origin, familial status or disability.

Since that landmark legislation was signed 45 years ago, the U.S. Department of Housing and Urban Development (HUD) has taken the opportunity each April to celebrate Fair Housing Month. This year's theme: "Our Work Today Defines Our Tomorrow," enables us to cast a spotlight on a persistent problem that exists in this country as individuals and families continue to face both blatant and subtle forms of housing discrimination.

I encourage you to read HUD Secretary Shaun Donovan's <u>The HUDdle Blog post</u>, where he shares that "Celebrating Fair Housing Month is always special—it gives us the chance to look back and reaffirm HUD's commitment to creating fair and decent housing in inclusive, sustainable

communities for all as well as an opportunity to reflect on how far we've come and how far we still have to go." At HUD's Fair Housing Month event at headquarters (pictured left) he repeated that message and spoke of as how proud he is after decades of work, this February, HUD issued a rule that formalized existing national standards for determining whether a housing practice violates the Fair Housing Act because it has a discriminatory effect. Having the rule in place makes it clear that HUD will use every enforcement resource available to fight unlawful housing discrimination under the Fair Housing Act.

With the National Fair Housing Alliance, HUD has launched a national media campaign to educate the public and housing providers about their rights and responsibilities under the Fair Housing Act. The campaign, titled "Fair Housing Is Your Right. Use It," includes English, Spanish, and Chinese radio and print public service advertisements that feature examples of actions which violate the Fair Housing Act and let the public know what to do if they experience housing discrimination. The campaign's PSAs will run in advertising space and in timeslots donated by the media.

In her blog post about the media campaign, <u>HUD Public Affairs' Shantae Goodloe passionately wrote</u>, "Just when you might think or hope that housing discrimination is a thing of the past, we're reminded it's still very much a part of society today. Consider the case of a single mother of two hoping to rent a two-bedroom apartment only to be told by the landlord that there is a 'one heart beat per room rule.' Or the deaf or hard-of-hearing individual who tried to rent an apartment only to be informed that persons like you 'belong in a nursing home.' <u>Be sure to check out the up close and personal stories from people about their experiences with housing discrimination and how they got help.</u>"

On April 11, I had the opportunity to share the compelling story of the single mom at the Fairfax County Office of Human Rights & Equity Programs' Annual Fair Housing Month event in Fairfax, VA. I told the nearly 150 housing advocates in attendance that you wouldn't think this kind of thing would happen in Fairfax County, but it does. Advertisements for rentals included language like a one-bedroom "ideal for a single, working person" and a four-bedroom, 2,000 square foot townhouse noting "no more than three people." Overly restrictive occupancy standards would undoubtedly discourage any family with children.

It's hard to believe that HUD and our Fair Housing Assistance Program (FHAP) partner agencies receive almost 10,000 complaints each year alleging some form of discrimination. And there are many other instances of discrimination that we know go unreported. The number of complaints is disturbing, but it's even more important to remember that each complaint represents a person or a family who feels their housing rights may have been unlawfully violated.

Throughout this month's Region III HUDLine News, you'll find stories about how our field offices are working in their communities to promote Fair Housing Month. You'll find an extensive listing of special events being held in HUD's offices as well as by our FHAPs and Fair Housing Initiatives Program (FHIP) partner agencies in each one of the Mid-Atlantic States.

You'll find the message we are trying to say and send loud and clear. If you feel like you've been a victim of discrimination (or know someone who has), there are a number of ways to file a complaint. You can call 1-800-669-9777, contact a local fair housing agency, or visit www.HUD.gov/fairhousing. Or, you can access HUD's mobile adaptive pages in <a href="English">English</a> and <a href="Spanish">Spanish</a>. Join the more that 1,000+ to download our <a href="app">app</a>! FEMA manages NFIP, which provides flood insurance policies that give millions of Americans a defense against flooding. The Federal Housing Finance Agency has announced that beginning July 1, Fannie Mae and Freddie Mac will require their servicers to "to offer eligible borrowers who are at least 90 days delinquent on their mortgage an easy way to lower their monthly payments and modify their mortgage without requiring financial or hardship documentation." Eligible homeowners whose mortgages are owned or guaranteed by Fannie and Freddie will need to demonstrate their "willingness and ability" to make three consecutive on-time payments after which their mortgages will be permanently modified. Now you can find out thanks to the **Consumer Financial Protection Bureau's brand new, online Consumer Complaint Data Base** comprised of more than 90,000 complaints and more than one million data points, covering approximately 450 companies. ## DSHA Celebrates \$5.1 Million Section 811 Project Rental Assistance Grant

Delaware State Housing Authority Director Anas Ben Addi (second from left) hosted HUD Regional Administrator Jane C.W. Vincent, Delaware Department of Health and Social Services (DHSS) Secretary Rita Landgraf and U.S. Sen. Tom Carper (I-r) on March 27 in Newark to celebrate Delaware's award from U.S. Department of Housing and Urban Development of \$5.1 million to create and sustain 170 units of affordable housing for people with disabilities over the next five years. In her remarks, Secretary Landgraf identified DHSS client Delores Elliott, of Lewes, as "the human face" of what housing assistance means to people who want to return to the community. After living in a nursing home for three years, Ms. Elliott, who receives housing assistance, found her own accessible apartment. Secretary Landgraf





said, "We asked Delores what it means to live in the community. She told us, 'I am happy. I waited a long time. Now, I am my own boss. I don't have to ask for permission to go to the store." " DHSS will identify and qualify people with disabilities, who have low incomes, for the housing assistance. The Delaware State Housing Authority will work with landlords to identify units eligible for the funding and then reimburse the landlords for a percentage of the monthly rent. ## **Communities Proclaim April Fair Housing Month in Delaware**

To kick off Fair Housing Month, the Housing Opportunities of Northern Delaware (HOND) hosted its 30th Annual Proclamation Signing Ceremony and Luncheon on April 2 in Wilmington. Those attending were witness to eight official proclamations from around the state. New Castle County Tom Executive Gordon and Dover Mayor Carleton Carey both noted the great demand for affordable housing for those who are working as well as individuals and families battling homelessness. Both expressed their commitment to promoting fair and equal access to housing in their respective proclamations. In his remarks, Delaware Human Relations Commission Chairman Calvin Christopher pointed out the continuing need to educate people in Delaware communities about their protections under the fair housing rights law. HOND, a private, nonprofit, fair housing organization that assists families in filing fair housing complaints and conducts education seminars, also serves as a HUD approved housing counseling agency. On April 29, HOND will continue its Fair Housing Month Celebration by honoring Amy Walls, President of the Diamond State Community Land Trust for her efforts to increase affordable housing in Sussex County and Karen Horton, architect and designer of Fair Housing Programs for the State of Delaware, for her work to champion the Analysis Impediments Study for Fair Housing. ### 100,000 Homes Fairfax Campaign Visits R-ICH

Tom Barnett and Dean Klein of the 100,000 Homes Fairfax Campaign will go almost anywhere to build support for their initiative to end homelessness. The two advocates, pictured to the left and right of District of Columbia Field Office Director Marvin Turner, traveled to the Philadelphia Regional Office on March 16 to meet with the Region III Interagency Council on Homelessness (R-ICH) to



share what they and 200 volunteers learned during the Registry Week they had just completed. Not only were they successful at recruiting more than 200 volunteers to survey everyone battling homelessness in Fairfax County, VA willing to be surveyed, but they also learned their names, their personal stories and took their photographs and videotaped them. Nearly 500 interviews were conducted (a decline of 12% from last year's count) with a collection of YouTube videos, website and the Partnership's Facebook and widespread media coverage documenting their efforts. The Washington Post and Huffington Post brought national recognition while local radio and television reports from WTOP, NBC4 and ABC7 and the Lorton Patch and Reston Patch (and more) introduced the volunteers and the individuals they interviewed to metro-area residents.

Through September 30, the U.S. General Services Administration (GSA) National Capital Region (NCR) will provide the public with an opportunity to purchase used furniture, electronics, and office supplies that federal agencies no longer need. Open from 8 a.m. to Noon every second and fourth Thursday of each month, items will be sold on a first-come, first-serve basis. GSA's regional office hosts the sale at its Surplus Sales Center, 8608 Loisdale in Springfield, VA 22150. Members of the general public can purchase furniture, laptops, CPUs, monitors, televisions, printers, and file cabinets. Buyers must be 18 years of age or older. Payment and removal of property is due on the day of sale by cash, checks or credit card. ### MonteVerde Rowe—Park Circle Renaissance

MonteVerde Rowe, an initiative to revitalize a full city block, continues to expand. AHC Greater Baltimore signed a contract on another house on the block, bringing the total to nine. One more home is under negotiation. AHC Greater Baltimore has now acquired nearly 50 percent of the homes on the block. The homes are being renovated from top to bottom with high-quality features that reflect the homes' gracious roots. Four homes will be ready to



sell this spring. MonteVerde Rowe is the leading edge of a large urban renewal area. The Pimlico Community Development Authority is overseeing the Master Plan for this area.



### **Residents Receive Fresh Produce from Food Bank**

Thanks to the Maryland Food Bank, nearly 200 residents of MonteVerde Apartments received 3,000 pounds of fresh produce earlier this month. Staff from the Department of Social Services was also on hand to register residents for food stamps and other benefits. Thanks to our resident volunteers who helped organize the food drop and distribute the food.

## **Maryland Health Enterprise Zones Announced**

Maryland kicked off an effort to bring medical services to disadvantaged neighborhoods by designating the state's first five "health enterprise zones" created under a law passed last year.

The \$4 million-a-year pilot project's five zones will be located in West Baltimore, Annapolis, Capitol Heights (Prince George's County), Greater Lexington Park (St. Mary's County) and Dorchester-Caroline Counties. The program's goals include reducing health disparities among races and ethnic groups, improving access to care in communities that lack services and reducing costs and hospital admissions by offering tax breaks and other incentives to physicians and community groups to bring medical care to underserved neighborhoods. ### **Low Maryland Housing Inventory Keeps Demand High**

The January inventory of homes for sale in Maryland dropped to the lowest volume since August 2005, according to the latest issue of Maryland Housing Beat, the Department of Housing and Community Development's (DCHD) monthly profile of the state's housing economy. January's drop in inventory was another indication that Maryland's housing market is getting stronger since low levels of inventory helps keep demand high. Home sales posted the highest volume in five years and median prices were up by more than 12 percent over last year. ## Frederick Featured on CNN's "America's Best Small Town Comebacks" List

The historic crossroads town of Frederick, nestled in western Maryland with its fabled clustered spires, is on CNN's list of "America's Best Small Town Comebacks;" part of the news organization's "Best of" series. Designated in 2001 as a Main Street Maryland community, the revitalization of downtown Frederick's historic shopping district serves as a model for communities across Maryland. Using DHCD neighborhood revitalization programs such as Community Legacy and Neighborhood BusinessWorks, the Downtown Frederick partnership and the City of Frederick have worked hard to enhance, promote and preserve the vitality of downtown by offering façade improvement programs, enhancing visitor experience with way-finding signage and renovating properties for new restaurants and retail opportunities. Frederick is one of only two Main Street communities in Maryland to receive the prestigious Great American Main Street Award from the National Trust for Historic Preservation for exceptional accomplishments in revitalization. Frederick also is a state-designated Arts and Entertainment district and is located in the heart of the Civil War Heritage area.

## O'Donnell Heights Groundbreaking on April 9

Mayor Stephanie Rawlings-Blake and Commissioner Paul T. Graziano are hosting a groundbreaking ceremony on April 9 for O'Donnell Heights. The large, multi-phase project is a massive revitalization of a 62-acre, 1940's public housing community on Baltimore's southeast side. Site work began about a month ago and is already about 15 percent complete. The first phase of the project includes leveling the slope of the site. So far, 833 trucks have brought soil to the site. Work on foundations should begin in late March. The project is a joint venture with AHC Greater Baltimore and the New Jersey-based Michael's Development Company. The Housing Authority of Baltimore (HABC) is also a key partner.

### Offshore Wind Legislation Passes the Maryland Legislature

The Offshore Wind Energy Act of 2013 passed earlier this week, making offshore wind a promising part of Maryland's goal to increase in-state renewable electricity generation to 20% by 2022. The legislation will incentivize the construction of a 200 megawatt offshore wind farm off the coast of Maryland and will create almost 850 manufacturing and construction jobs. Every megawatt-hour of wind we generate in Maryland is a megawatt-hour we do not generate from fossil fuels that pollute our air, and make people sick. By advancing this project, we can prevent as much as 7.5 million tons of climate change-causing pollution from being pumped into our atmosphere. The legislation's passage is a win for jobs, for the environment, and for future generations of Marylanders.

### In Celebration of Fair Housing Month 2013

Baltimore Field Office (BFO) Director Carol Payne will provide the opening remarks as the BFO Fair Housing and Equal Opportunity Division, in collaboration with The University of Maryland School of Law and Baltimore Neighborhoods, Inc., presents an April 12 Fair Housing Month event, "Affirmatively Furthering Fair Housing: Building Inclusive Communities." The full-day event will include topics of affirmatively furthering fair housing, sustainable housing and communities and fair housing implications and housing equity through fair housing, will be held at the University of Maryland School of Law's Westminster Hall in Baltimore. Joining FOD Payne in a panel discussion on sustainability and the Baltimore Regional Analysis of Impediments will be HUD's Salin Geevargheese of the Office of Sustainability, Poverty & Race Research Action Council's Megan Haberle, Baltimore Metropolitan Council's Mike Kelly and Maryland Disability Law Center's Lauren Young. ## Health Care for Homeless Veterans Summit "Partnering in Veteran-Centered Care"

On Feb. 26, HUD Public Housing and Field Policy and Management staff participated in a Veterans Health Care Summit held at the U.S. Veterans Administration Medical Center in Aspinwall, PA. Attendees held roundtable discussions about obstacles to providing adequate services to homeless veterans. Dialogue also centered on the wide variety of federal, state and local funds available to combat homelessness amongst veterans and

barriers to obtaining such funds at times. Community stakeholders, including non-profit organizations, local officials, and federal and state agencies, all share the same intent on increasing efficient and effective collaboration of collective resources to assist in ending veteran homelessness as expeditiously as possible. Attendees agreed the words homeless and Veteran should never be used together and that having a shared vision further strengthened the resolve of service providers to continue to "fight the battle" against veteran homelessness at every turn. ## Supportive Housing for Persons with Disabilities Project Rental Assistance Demonstration Moves Forward

The Department of Public Welfare (DPW) and the Pennsylvania Housing Finance Agency (PHFA) will utilize \$5.7 million in federal rental assistance to make accessible housing more affordable for 200 low-income individuals with disabilities. Pennsylvania was one of 13 states selected to receive this rental assistance money from the U.S. Department of Housing and Urban Development. PHFA, along with DPW, will create new housing opportunities by using methods developed through PHFA's Low-Income Housing Tax Credit Program and other affordable housing programs administered by both agencies. This rental assistance is part of HUD's first-ever selection of Section 811 Supportive Housing for Persons with Disabilities Project Rental Assistance Demonstration.
