

### Promote Decent Affordable Housing

Helping families find safe, decent and affordable housing is a vital part of our mission. We realize that homeownership may not be for everyone, particularly those with limited or unstable income. Improving the quality and accessibility of affordable rental housing for families, persons with disabilities, the elderly and other individuals remains a top concern. One of our office goals was to provide information on the many rental opportunities available to Wyoming communities. We accomplished this through the use of "toolkits" on the

HUD's Multifamily housing staff provided FHA finance/ refinance and Section 202/811 (elderly and disabled) program training to nonprofit organizations, developers, property managers and lenders. Staff from HUD's Office of Public Housing provided training on family self-sufficiency, individual development accounts and the housing choice voucher programs to Wyoming's Housing Authorities. We also met regularly with the Wyoming

The Section 108 program was also used to fund an addition to the St. Joseph's Children's Home in Torrington. Meetings with the continuum of care (CoC) and other organizations were held to promote programs for the homeless. Wyoming is closer to meeting the challenges of ending chronic homelessness. In cooperation with HUD's environmental office, we promoted healthy homes by providing environmental and leadbased paint training. We discussed the Affordable Communities Initiative with our housing partners to help identify barriers to the production and avail-

## Ensure Equal Opportunity in Housing

This past April marked the 36th anniversary of the Civil Rights Act of 1968 and HUD's commitment to ending discrimination through education and enforcement of our national fair housing laws. The Casper Field Office sent toolkits to Wyoming's mayors, Governor and Tribal leaders to encourage them to promote fair housing in their communities. We staffed a booth at Casper College providing students and visitors information on fair housing. We set up a display in the Casper post office lobby to raise public awareness of fair housing. In conjunction with our housing counseling partners, we made numerous presentations on fair housing. We participated in the Mega Disabilities conference, provided accessibility training and set up a booth at the annual diversity picnic to provide information to our industry partners. We met with the cities of Casper and Cheyenne, and the Governor to discuss the possibility of a substantially equivalent fair housing law. We have a long way to go, but the Casper Field Office is "keeping the dream alive."

#### Embrace High Standards of Ethics, Management and Accountability



This goal focuses on the development of the Casper Field Office and HUD's workforce. It is designed to improve our performance and efficiency, while maintaining high quality customer service with integrity. The Casper Field Office participated in several internal and external staff trainings. Our office took part in the annual GRO-Biz conference (Wyoming's small business conference) and the Native American Business Expo. These conferences provided an opportunity for private vendors and small businesses to

meet with contracting officers and receive information on the government contract process. Exhibitor booths and workshops were set up to help participants learn how to develop a new or existing business by taking advantage of opportunities with the federal government. The Casper Field Office coordinated with HUD's program offices to provide training to further our knowledge and development; included were staff trainings on community planning and development, public and multifamily housing, fair housing, FHA connection and contract training. We created a quarterly newsletter to inform our customers about HUD activities in Wyo-We maintained our ming. local website, so that it is current and informative. We made better use of training resources available to us through our agency and the community. In the last two years, our office staff has been reduced by half. It has become critical for us to be well trained; insuring that we can continue quality service and program delivery for our Wyoming partners.

# Promote Participation of Faith-Based and Community Organizations

Faith-based and community organizations play a significant role in our communities. HUD conducts outreach, training and technical assistance to these organizations to increase their participation in our programs. The Casper Field Office serves as the Federal Liaison to the Governor's Advisory Board on Faith-Based and Community Initiatives. We provided two

grant-writing workshops this year. The first provided a chance for faith-based and community groups to meet with organizations that provide grants and the second was on how to become more competitive for federal grants. We sent out toolkits to mayors, the Governor and our Tribal leaders on the Faith-Based and Community Initiative. In addi-

tion, our office hosted a free web clinic for our partners on how to design a great, low cost public service website. The training showed our partners how to take advantage of the internet to deliver information and services to an online audience. Free software was provided to use in building websites to assist their communities.
