Notice of Amendment and Technical Correction to the Notice of Funding Availability for HUD's Fiscal Year 2011 Asthma Interventions in Public and Assisted Multifamily Housing Grant Program

AGENCY: Office of the Secretary-Office of Healthy Homes and Lead Hazard Control, HUD.

ACTION: Amendment and Technical Correction to the Notice of Funding Availability (NOFA) for HUD's Fiscal Year (FY) 2011 Asthma Interventions in Public and Assisted Multifamily Housing Grant Program: FR-5500-N-06C.

SUMMARY: On April 8, 2011, HUD published the Notice of Funding Availability (NOFA) for the Fiscal Year (FY) 2011 Asthma Interventions in Public and Assisted Multifamily Housing Grant Program. At that time, the available funding for this program was unknown since enactment of the FY2011 HUD appropriations had not been completed. On April 15, 2011, the Department of Defense and Full-Year Continuing Appropriations Act, 2011 (Public Law 112-10) was approved and provided the funding for the HUD's FY2011 programs. This notice modifies the total available funding for this program. Based on the enactment of the FY2011 HUD appropriations, approximately \$2 million is available for this program.

This Notice also deletes all references that indicate the amount of funds is subject to enactment of FY2011 Appropriations or changes that may occur as a result.

This Notice also amends the table, under Section V.A.3.b.(1)(a), for Rating Factor 2, Need and Extent of the Problem, which depicts points to be allocated for the asthma prevalence against the national average of the target age group in the community target area to reflect the 5 points available for this subfactor.

The Notice is amended to include the Certification of Consistency with Sustainable Communities Planning and Implementation (HUD2995). The Certification form HUD2995 will be found in the instructions download associated to this program NOFA at grants.gov.

This Notice also amends the deadline date to 11:59:59 p.m. on June 14, 2011.

I. Amendment to Total Available Funds

On April 8, 2011, HUD published the Notice of Funding Availability (NOFA) for the Fiscal Year (FY) 2011 Asthma Interventions in Public and Assisted Multifamily Housing Grant Program. Under the headings “summary” at page 1; “available funding” and “anticipated awards” at pages 2-3, Sections G.2. and G.3., respectively, of the Overview Information; “authority” at page 7, Section I.F. and “funding available” at page 7, Section II.A. of the Full Announcement, HUD stated that the available funding is subject to enactment of the FY2011 HUD appropriations. Based on the enactment of the FY2011 HUD appropriations, approximately \$2 million is available for this program.

II. Technical Correction to the Points Awarded for Asthma Prevalence Above the National Average under Rating Factor 2: Need and Extent of the Problem.

The table at page 20, Section V.A.3.b.(1)(a), under Rating Factor 2, Need and Extent of the Problem, is corrected to reflect the point allocation of a total of five (5) points allocated under this subfactor. Therefore, the table identifying the number of points awarded based on the asthma prevalence against the national average of the target age group in the community your target area is in, is changed as indicated below:

% above National Average	Points
0.1 to 1.0	3
1.1 to 2.0	4
2.1 and above	5

III. Amendment to the Deadline Date.


This Notice also amends the following references to the deadline date for the Asthma Interventions in Public and Assisted Multifamily Housing NOFA as follows:

Page 16, Line 1, Section IV.C., Submission Dates and Timely Receipt Requirements, is amended to read: "The application deadline is 11:59:59 p.m. eastern time on June 14, 2011."
