## Amendment to the Notice of Funding Availability for HUD's Fiscal Year 2011 Healthy Homes Production Program

**AGENCY:** Office of the Secretary-Office of Healthy Homes and Lead Hazard Control, HUD.

**ACTION:** Notice of Amendment to the Notice of Funding Availability (NOFA) for HUD's Fiscal Year (FY) 2011 Healthy Homes Production Program, FR-5500-N-03A.

**SUMMARY:** On April 8, 2011, HUD published the Notice of Funding Availability (NOFA) for the Fiscal Year (FY) 2011 Healthy Homes Production Program. At that time, the available funding and anticipated number of awards for this program was unknown since enactment of the FY2011 HUD appropriations had not been completed. On April 15, 2011, the Department of Defense and Full-Year Continuing Appropriations Act, 2011 (Public Law 112-10) was approved and provided the funding for the Department of Housing and Urban Development's (HUD) FY2011 programs. This notice modifies the total available funding and anticipated number of awards for this program. Based on the enactment of the FY2011 HUD appropriations, approximately \$13.3 million is available for the program included in this NOFA and approximately seven grants will be awarded.

This Notice also deletes all references that indicate the amount of funds is subject to enactment of FY2011 Appropriations or changes that may occur as a result.

There are no other modifications to this NOFA.

Based on the enactment of the FY2011 HUD appropriations, approximately seven grants will be awarded for the program included in this NOFA.
