Today's publication again extends the application deadline date of the Section 202 Pre-Development Grant Program NOFA to allow time for an additional five grantees to apply for these funds. Applicants that have already submitted an application under the Notice of Funding Availability (NOFA) for the FY2010 Section 202 Pre-Development Grant Program via Grants.gov are not required to resubmit under this technical correction.

This technical correction notice extends the application deadline date to **March 17, 2012** to allow the additional five selected applicants sufficient time to submit an application for funding consideration under this program. Applicants are still required to comply with the requirements set forth in the FY2010 General Section.
