**HUD's Fiscal Year (FY) 2012 Notice of Funding Availability (NOFA) for  
Section 811 Project Rental Assistance Demonstration Program**

**AGENCY:** Office of the Assistant Secretary for Housing-Federal Housing Commissioner, HUD.

**ACTION:** Notice of Technical Correction.

**SUMMARY:** On May 15, 2012, HUD posted a NOFA for the FY 2012 Section 811 PRA Demo program. On July 9, 2012, HUD posted a Technical Correction to the NOFA. This second Technical Correction extends the application deadline date to Tuesday, August 7, 2012, to accommodate the lack of service at the Central Contractor Registration (CCR) because CCR is transitioning to a new platform "System for Award Management" (SAM).

**APPLICATION DEADLINE DATE:** The application deadline date has been extended to 11:59:59 pm eastern time on **August 7, 2012**. All other requirements for timely receipt remain the same.



**BACKGROUND:** On May 15, 2012, HUD posted the FY 2012 Section 811 PRA Demo NOFA to the federal website [www.Grants.gov](http://www.Grants.gov). A Technical Correction to the NOFA was posted to Grants.gov on July 9, 2012. This is the 2<sup>nd</sup> technical correction. This technical correction changes the deadline to **Tuesday, August 7, 2012** at 11:59:59 p.m. eastern time.

**TECHNICAL CORRECTION:** This correction changes the application deadline date to 11:59:59 p.m. August 7, 2012. No other changes are made to the NOFA. Applicants who have previously submitted an application do not have to resubmit an application, but may do so if they want to change their application prior to the deadline date and time. Applicants that have not submitted their application may do so in time to meet the new deadline date and timely receipt requirements for this NOFA. There is no need to pull down another application.
