**SUBJECT: Home Investment Partnerships (HOME) Program
County of Los Angeles HOME Consortium Meeting**

The Office of Community Planning and Development, Los Angeles Office, is convening our second meeting with all Los Angeles County-area CPD Formula grantees (both current HOME Participating Jurisdictions and CDBG Entitlement Communities) to discuss the potential HOME Consortium that the County of Los Angeles will be creating.

On September 29, 2011, HUD convened the first meeting of the proposed L.A. County HOME Consortium. The Los Angeles County Community Development Commission (CDC) shared highlights of their key HOME program activities. Cities that attended asked a lot of good questions ranging from geographic set-asides to program income. HUD provided resources for everyone to review and to help in this difficult decision process.

This is an opportunity to see the newly constructed 83 unit new senior development for households earning no more than 30% or 50% of area median income; in 32 of these units the senior may be developmentally disabled. The developer/owner is LINC Housing.

At this meeting, the CDC will present the Consortium framework and the timeframe for action.
