MESSAGE FROM THE DEPUTY REGIONAL ADMINISTRATOR



On Thursday, as we celebrate the Fourth of July, we remember that America was founded on the principle that all of us are created equal and that we share the rights of life, liberty and the pursuit of happiness. We celebrate and commemorate the principles of democracy and freedom upon which the United States was founded and for which millions of people still fight and die today.

At HUD and in Region VII, we honored our veterans during Memorial Day celebrations across the country, and HUD staff eagerly contributed shoes and clothing at local Veterans Stand Downs held recently. In addition, HUD, VA, and local housing agencies continue to work together to confront and end veteran homelessness once and for all.

A core part of HUD's mission is to also enforce and administer the Fair Housing Act through our investigations and legal resolution of the cases we file, In June, HUD released the nation's firstever national study examining housing discrimination against same-sex couples in the private rental market. The study, *An Estimate of Housing Discrimination Against Same-Sex Couples*, measures the treatment same-sex couples receive from rental agents when inquiring about apartments advertised online, as compared to how otherwise similar heterosexual couples are treated. While the study is a first step toward future research on same-sex housing discrimination, HUD will continue to aggressively investigate and prosecute these kinds of violations.

Each year, June is nationally recognized as Homeownership Month and as such, HUD's theme for this year <u>Rebuilding the Middle-Class.</u> focused on helping first-time buyers gain access to the credit they need to buy a home, build equity and reach the middle-class. The housing market is rebounding, but, our work is far from finished. We have a long way to go to ensure that every distressed homeowner gets help and every qualified buyer is treated fairly. Too many responsible families who want to buy are still being locked out of mortgages and the middle class. Working with partners, like you, on the ground, we can shape a housing market that is stronger and safer than ever before. Thank you for your help in continuing to restore the dream of homeownership, creating a stronger middle-class and a stronger America.

HUD'S OFFICE OF FIELD POLICY AND MANAGEMENT WINS W. EDWARDS DEMING AWARD Graduate School USA recognizes HUD's excellence in workforce development and training

The U.S. Department of Housing and Urban Development's Office of Field Policy and Management (FPM) was presented with the Graduate School USA's annual W. Edwards Deming Award for a staff training and orientation program to reinforce the use of next generation cloud computing. The W. Edwards Deming Award recognizes impressive workforce development and training initiatives that measurably improve an organization's performance and impacts its mission.

FPM was selected for implementing its training and orientation program to reinforce the use of cloud computing for tracking and reporting project performance in order to improve its ongoing reporting to Congress and other key constituents.

The award's namesake is Dr. W. Edwards Deming, who taught at Graduate School USA for 20 years and is considered the father of Total Quality Management. His work incorporated the idea that employees and managers at all levels of private industry and government have a responsibility to cooperate to improve products and services.

OBAMA ADMINISTRATION EXTENDS APPLICATION DEADLINE FOR THE MAKING HOME AFFORDABLE PROGRAM

The U.S. Department of the Treasury and the U.S. Department of Housing and Urban Development announced an extension of the Obama Administration's Making Home Affordable Program through December 31, 2015. The new deadline was determined in coordination with the Federal Housing Finance Agency (FHFA) to align with extended deadlines for the Home Affordable Refinance Program (HARP) and the Streamlined Modification Initiative for homeowners with loans owned or guaranteed by Fannie Mae and Freddie Mac. The Making Home Affordable Program has been a critical part of the Obama Administration's comprehensive efforts to provide relief to families at risk of foreclosure and help the housing market recover from a historic housing crisis. The program deadline was previously December 31, 2013.

Homeowners seeking assistance with their mortgage payments should remember that there is never a fee to apply to the Making Home Affordable Program. Homeowners can work with a HUD-approved housing counseling agency free-of-charge to understand their options and apply for help. HUD ANNOUNCES FIRST-EVER SAME-SEX HOUSING DISCRIMINATION STUDY Research seen as important first step in identifying possible patterns of discrimination in rental housing

FHA HOT Topics & Updates/FHA Appraisal Training

On June 18-19, 2013, staff from the Denver Homeownership Center (HOC) conducted classroom training in the Kansas City HUD Regional Field office on FHA HOT Topics & Updates (June 18) and The FHA Appraisal (June 19).

FHA HOT Topics & Updates training provided clarification to current Underwriting Hot Topics, Insuring/Eligibility Issues, and Frequently Asked Questions (FAQs) in today's FHA lending environment. Topics covered FHA Updates, including most recent Mortgagee Letters, Maximum Mortgage Calculations, Refinance Transactions, FHA Real Estate Owned, Credit, Income and Asset Scenarios, as well as utilizing FHA Systems.

The one-day FHA Appraisal Training discussed FHA appraisal requirements including FHA Appraisal Protocol and updates to the FHA appraisal policy. Attendees also learned how to determine property eligibility. The course provided a refresher to seasoned FHA appraisers and valuable information to appraisers new to the FHA roster.

Both events were well attended.

The meeting concluded with HEARTH ACT updates and Questions & Answers for CPD Staff.



On May 23, 2013, twelve employees of the Des Moines Field Office successfully completed the planning, preparation and serving an evening meal to over 250 men and women at Central lowa Shelter and Services.

The Central Iowa Shelter and Services is a homeless shelter consisting of 150 emergency beds, 38 Section 8 efficiency apartments, and 19 apartments for veterans. In addition to the sleeping quarters, the facility includes a computer lab, food pantry, clothing closet, large dayroom, commercial kitchen, healthcare clinic, and an open backyard area

Every day meals served to individuals at the shelter are prepared and served by volunteers.

SURFS UP! The St. Louis BEACH Project Achieves Early Success

In February of 2013, the City of St. Louis launched a bold initiative called the BEACH Project to coordinate multiple governmental, charitable and for-profit partners to end chronic homelessness in St. Louis. Beginning of the End: Abolishing Chronic Homelessness (BEACH) is already showing dramatic results. Antoinette D. Hayes Triplett, Division Manager for the City of St. Louis' Homeless Services Division, said "Our case managers and other partners (aka Lifeguards) are doing amazing work towards ending chronic homelessness. 101 of the 138 (or 73%) of the chronically homeless persons counted by the St. Louis Continuum of Care during the January 2013 homeless census are engaged with case management and other services, and 32 of those served have been provided very nice one bedroom apartments."

The BEACH Project involves twenty partners that have joined the city to provide mental health services and a stable place to live for the chronically homeless in St. Louis. This innovative partnership is funded by \$1.25 million in HUD Community Planning and Development grants, and brings together federal, state, and local government agencies with faith-based organizations, businesses, housing providers, and non-profits. The BEACH Project is part of Mayor Francis Slay's 10-year plan to end chronic homelessness, and could make St. Louis the first city to end chronic homelessness.

Partners/Lifeguards are giving the City high praise for addressing urban homelessness as both a human services issue and a community development opportunity. By comprehensively addressing the human and housing needs of the homeless, the City was able to close a homeless encampment located at 2nd and Plum Streets, referred to as "Camp Plum". The closing took place in stages beginning June 12th, 2013 involving the relocation of 24 homeless people who lived in the riverfront encampment. Former residents of the encampments will continue to be offered housing assistance and case management services to assist their transition into their new quarters. "Contrary to what other cities have done in shutting down encampments by arresting residents and destroying their property, we chose to address the underlying problem – lack of housing – by assisting individuals to access permanent supportive housing," added Bill Siedhoff, Director of Human Services. "For many of the residents it had been a long time since they had a place they could call home."

Omaha HUD Multifamily Program Center and Office of Counsel Team Up



On Friday, May 17, 2013, the Omaha Multifamily Program Center and the Legal Division, completed a Final Closing for a \$15,021,100 loan on Tamarin Ridge Apartments, a 180unit market rate project located in Lincoln, NE. The project was insured under the Section 221(d)(4) mortgage insurance program for new construction on March 28, 2011. Construction began on April 5, 2011 and was found to be successfully completed on December 28, 2012.

Re-Entry Alliance Program

On May 31, 2013, Field Office Director (FOD) Earl Redrick visited with members of the Re-Entry Alliance of Nebraska (RAN) at their monthly program meeting in Lincoln, NE. The meeting, held as public forum, was used to address the challenges of reintegrating ex-offenders by providing jobs, housing, health care, substance abuse counseling and community involvement. FOD Redrick discussed the Omaha Field Office's strong involvement in housing and homelessness issues throughout the state. The newly formed organization has formed collaborative partnerships with other organizations, individuals, and various service providers, dedicated to increasing public awareness and safety regarding ex-offenders and to support ex-offenders re-entering the community.

Omaha HUD Field Office - Western Nebraska Road Tour and Community Conversations

On May 29, 2013, FOD Earl Redrick was guest speaker at a ribbon-cutting event for City Impact Homes. The event, in Lincoln, celebrated the opening of 15 rent-to-own townhomes for working family households at below 60% Area Median Income (AMI).

City Impact Homes is a local, non-denominational, 501(c)(3), nonprofit organization that provides educational, recreational and housing opportunities for low-income families throughout the city.

The newly-constructed project consists of 3 to-5 bedroom units. Tenants will pay electricity, water and sewer and the owner will pay for garbage removal. City Impact Homes, LLC will be available to income qualified households. The development will also be designed and marketed to accommodate families currently working with the City Impact on educational and family stability goals.

Approximately 75 local leaders, housing providers, nonprofit organizations, and local neighborhood residents participated in the 2-hour celebration.
