Make a Difference Award (MADA) First Annual Presentation

The HUD Caribbean PIH Office's "Make a Difference Award" (MADA) is given to a Section 8 Housing Choice Voucher Program and/or for Public Housing (Low Rent) program, activity, project, management tool, or technique that *fulfills one or more* of the following basic requirements:

- generates a significant positive impact on those it is intended to benefit or serve in their communities;
- can be replicated locally, regionally or nationally;
- demonstrates the effective use of partnerships with external partners, units of government, and/or the private sector;
- demonstrates creativity or resourcefulness in assisting the Public Housing Agencies (PHAs) customers;
- develops innovative or more efficient ways to address community problems in a timely manner;
- demonstrates effective examples of assisting customers to leverage resources;
- demonstrates substantial cost savings and efficiency for the department; or
- demonstrate networking capacities with other PHAs

The HUD Caribbean PIH Office recognizes its clients. The Public Housing Agencies (PHAs), and their internal programs/ activities/ personnel that are making a difference in the lives of HUD customers within Puerto Rico and the Virgin Islands through the provision of outstanding customer service and innovative practices. These are PHAs staff or sub-recipients that work closely with assigned communities, perform needs assessments, find opportunities for improvement, and/or implement actions to improve the quality of life for individuals and families. The Caribbean PIH's "Make a Difference Award" is intended to provide recognition for those that have demonstrated exceptional practices leading to measurable and replicable outcomes in customer service and outstanding community initiatives in self-sufficiency and empowerment.

Brief of the Nominees

J.A. Machuca and Associates, Inc.

This public housing management agency created a program called "Programa AME" which uses training, maintenance and employment as tools to deal with public housing unemployment, school dropouts, sex-offenders, users or abusers of drugs or alcohol and those at risk of becoming involved in criminal activities. In order to reinforce self-esteem the program provides training, part-time employment and job search techniques. Absences are not excused except for the attendance of a court hearing or health appointment and the participant must make-up the time of absence.

The University of the Virgin Islands

Through a partnership with VIHA, the UVI has established three ancillary service delivery arms that address the needs of the local population including public housing residents. These entities include: UVI Community Engagement and Life Long Learning providing workforce development training opportunities, UVI Cooperative Extension Service providing life skills development and youth enrichment activities, and Small Business Development providing entrepreneurial training and business counseling services. This partnership leveraged resources and training opportunities for youth and adults residing in public housing. These opportunities have been provided at such a time when community resources have decreased and VIHA's operating budget has been unable to sustain costs associated with implementing resident programs.





Evelyn Ramirez, Municipality of Cabo Rojo (Section 8)

Evelyn Ramirez has always been proactive in the management of her PHA. She is always creating new initiatives for Section 8 participants such as a budget and home expenses management and promoting self-sufficiency for program participants. She has led efforts through a network of housing and health organizations to help address community needs. Ms. Ramirez has been a champion for Section 8.

Gilberto Rivera, Municipality of Humacao (Section 8)

Gilberto Rivera has maintained a highly effective system of data management of section 8 participants and applicants. He has achieved maximum voucher utilization. The system provides flexibility and the capacity of quick reaction to changes in occupancy. He has developed, organized, and implemented activities to encourage participants to obtain better living opportunities such as: skill development seminars, financial planning and budget preparation workshops and health clinics. He has also established interagency collaboration agreements to refer participants.

Carmen Ortiz, Municipality of Sabana Grande (Section 8)

Carmen Ortiz has 19 years of experience as a PHA Coordinator. She has generated a positive impact on her PHA while becoming a technical point of reference assisting other PHAs throughout the island by providing them an overall orientation of the section 8 program. She has become a focal center for information for other PHAs by establishing a close network with them; sharing affirmative measures implemented to better assist housing authorities to fully comply with all federal, state and local laws. She has been a leader not only in her PHA but has been a lightning resource for change within her PHA as well as for others.

Sylvette Fontanet, PRDH (Section 8)

Sylvette Fontanet is the coordinator for the HUD VASH program (Veteran Affairs Supportive Housing Vouchers). During the past five years she has been the link between the Veteran Affairs Medical Center management and the staff of Puerto Rico Public Housing Administration ensuring HUD VASH voucher issuance. She has been a key player in housing chronically homeless veterans in PR. The main beneficiaries of the activities conducted by Ms. Fontanet are the 118 veterans and their families that have been served through the HUD VASH program.
