Using NSP to create housing, jobs in Vermont

This month marks the completion of three years of Vermont's Housing Acquisition & Rehabilitation Program (HARP)—a program that has helped renovate 55 homes including an historic St. Albans colonial purchased by first-time homebuyers, Meghan and Joseph Swan. The purchase culminated their quest to buy a home for their active family of five, made possible with help from VHFA, **Vermont Agency of Commerce and Community Development** (ACCD) and **Champlain Housing Trust** (CHT).

The HARP program is funded through \$9.9 million in Housing and Economic Recovery Act funds from the **U.S. Department of Housing & Urban Development (HUD).** The funds are part of the larger Neighborhood Stabilization Program (NSP) administered by ACCD and HUD.

Under the HARP program, VHFA works with Champlain Housing Trust and four other HomeOwnership Centers throughout Vermont to acquire, rehabilitate and re-market foreclosed homes. The 4-bedroom home purchased by the Swan family needed extensive renovations after foreclosure including a new roof, weatherization, new kitchen cabinets and countertops, refinishing wood floors, new bath and kitchen flooring and chimney repair. The home also received a new furnace and appliances.

Since June 2009, VHFA has restored 35 homes and sold them to income-eligible Vermonters. Most homes can be viewed on VHFA's web site. Read more about $\underline{\mathsf{HARP}}$ program

HUD Priority: Green Affordable Housing

Every year HUD identifies certain high priorities. This year, in an effort to become more "place-based" in the delivery of programs HUD has identified particular places in which to concentrate our efforts. As a result, regional office staff in Massachusetts and Rhode Island are making a special effort to encourage the green retrofit of HUD-supported affordable housing in the Providence-Fall River-New Bedford Metropolitan Statistical Area.

The Office of Policy Development and Research chose these areas to focus on given the age of the housing stock and number of households that fall into the low-income categories. Older homes generally equate to higher utility costs therefore any savings that green retrofits produced would mean that HUD, its partners and the families living there would have more money to spend on other essentials.

To this end, each of the major program staffs are working with partners to find ways to improve energy efficiency in this area – which includes the entire state of Rhode Island and Bristol County, Massachusetts.

This project has been underway for six months and is expected to yield ever-increasing benefits as time goes on. It promises to be a model not only for New England but for the entire country, as HUD looks for ways to save money on energy costs and use the cost savings to meet other housing needs.

Collaborative effort transforms Massachusetts development

Every day, local Housing Authorities (HAs) face the challenge of providing affordable housing to their residents. Much of the hard work goes unrecognized. Recently, at the annual awards dinner of the Watertown-Belmont Chamber of Commerce, the Watertown Housing Authority was spotlighted with a Special Recognition Award. This was a day to celebrate the accomplishments and dedication of staff across several agencies in providing affordable housing to the Water-



town community. Brian Costello, Executive Director of the Watertown Housing Authority, takes pride in the fact that "the recently renovated elderly complex now known as the E. Joyce Munger Apartments is a shining example of what senior housing should be."

Watertown, a city west of Boston, has one federally funded development. Originally built in the early 1980s, it was falling apart and even under discussion to be demolished. Staff from the Boston Office of Public Housing worked closely with the HA to discuss possible solutions to address three decades of leaking roofs. The housing authority applied for and was awarded a \$3.75 million competitive grant through the American Recovery & Reinvestment Act (ARRA). "If not for President Obama's American Recovery and Reinvestment Act, this complex would now simply be a concrete pad. Instead we have a beautiful structure that will continue to serve the community for many, many years to come," said Mr. Costello.

When the HA received the funds, they immediately moved to procure bids and remedy all of the structural deficiencies from the original construction. The work was completed last December. Dwight Hebert, senior facilities management specialist at HUD, remarks: "I had an opportunity to visit this site and was so taken by the metamorphosis. The building is not your stereotypical public housing façade and the interior is equally warm and inviting." The building includes 50 units of senior housing.

"This is just one example of the successful collaborative efforts taking place throughout our region between HUD staff and our partners to improve the quality of life for residents," said Regional Administrator Barbara Fields. As residents praise the leadership of both HUD and the Watertown HA in the effective rehabilitation effort, Region 1 is proud to be a partner in these efforts.
