# Mayor Taveras, HUD Celebrate 23 Start-Ups



City of Providence Mayor Angel Taveras, HUD New England Regional Administrator Barbara Fields and other city and federal officials recently gathered to celebrate the City's Innovation Investment Program (IIP) and the 23 New Economy start ups that received funding through an equity investment program supported by the U.S. Department of Housing and Urban Development.

"As Providence strengthens its fiscal ground and makes moves forward on a path for progress, we need to make every effort to foster an economic climate that promotes job growth and makes use of our creative capital. The businesses that participated in the Innovation Investment Program will help create new jobs in our City," said Mayor Taveras. "More importantly, they will serve as ambassadors for other business owners and entrepreneurs who will look to Providence as a land of opportunity."

Providence used \$1 million of designated HUD funds to provide \$50,000 of seed payments to upstart, entrepreneurial ventures. In return, the City requires the businesses to headquarter in Providence, remain within the City for at least one year and create one full time position for every \$35,000 of funding. The program allows the City to take an equity investment share in startup companies with the directive that those companies create at least two, new full time positions. In total, the City's support for the IIP could create as many as 50 new jobs in emerging fields.

### **HUD** funds make an impact: reaching homeless youth living with HIV

HUD's Office of HIV/AIDS Housing ensures that HUD initiatives are responsive to the special needs of people living with HIV/AIDS.

Through the office's competitive grants program, funding is available for organizations serving this population. One of the 2011 grantees is the Justice Resource Initiative (JRI), a Boston-based nonprofit organization that helps people who are homeless to access supported housing. When JRI applied for this grant, they decided to use the funding to reach a population they did not previously work

with young adults.



In January 2012, JRI launched the JRI Youth Housing Initiative, which will run for three years under the HUD grant. This innovative program provides housing and support for homeless youth ages 18-25 living with HIV. In addition to assisting youth in applying for housing vouchers, JRI will conduct individualized assessments and work with the individuals to access education and career opportunities, as well as to connect them to resources ranging from mental health to financial literacy. Susan Buoncuore, Program Director at JRI, applauds HUD's grants programs, saying "These funds gave us the opportunity to fund housing and supported services for youth- we wouldn't have done it without the support of the Department of Housing and Urban Development."

At the end of the three years, JRI, like all the HUD grantees under this program, will develop an integrated HIV Housing Plan (IHHP). This document, which will include lessons learned, partners, successes, and challenges, will be made public and will serve as a tool for communities interested in starting similar programs. In this way, HUD is leveraging its funding to create an even bigger footprint on the road to ending youth home-
