A Message from the Regional Administrator

Dear Friends:

Last week I gathered with legislators, community partners and area families at the People's Emergency Center (PEC) to recognize and celebrate the 25th anniversary of the McKinney-Vento Homeless Assistance Act. Established in 1987, the McKinney-Vento Act was the first significant federal law in response to homelessness. In Philadelphia, it provides federal funding to nearly 100 programs that offer a range of housing and support services to people experiencing homelessness, and ensures that children who do not have permanent housing are able to receive an education. The McKinney-Vento Act has enabled PEC and other partner agencies to breathe new life into communities by helping individuals experiencing homelessness with emergency and transitional housing, employment training, counseling support and access to technology.

The 25th Anniversary event celebrated key successes in the fight against homelessness by local agencies, and recognized the critical importance of the reauthorization of McKinney-Vento funding. Children from area shelters presented McKinney-Vento birthday cards. It was my honor to represent HUD and all we do to help families and individuals achieve greater quality of life.

RAD works to preserve the nation's stock of affordable rental housing for people with the greatest need, promotes efficiency and builds strong, stable communities. RAD is designed to test new preservation tools for the HUDassisted housing stock by allowing:

- Public Housing and Moderate Rehabilitation properties to convert, through a competition; and
- To convert tenant-based vouchers to project-based assistance.

SETTLEMENT SAVVY... UPDATES FROM THE STATES

MARYLAND: The Maryland Attorney General's office held a workshop in Baltimore on July 10 to bring homeowners hoping to see benefits from the national settlement, and those struggling with payments, together with non-profit housing counselors who work with distressed borrowers. Other workshops are also being planned. Read the news story <u>here</u>.

In one of the largest fair-lending payouts in history, Wells Fargo agreed to spend at least \$175 million to <u>settle</u> <u>federal accusations</u> that it steered black and Latino borrowers into high-cost loans and charged them excessive fees in the Washington-Baltimore-Northern Virginia, DC-MD-VA-WV combined statistical area between 2004 and 2009. The settlement with the nation's largest home mortgage lender is rooted in a <u>lawsuit filed four years</u> <u>ago by Baltimore</u> over fair-lending violations. It culminated in what federal officials called "systemic discrimination" spanning 36 states and involving more than 34,000 minority customers over five years.

DELAWARE From Delaware's share of the \$25 billion foreclosure settlement, \$4 million will be allocated to the Delaware Emergency Mortgage Assistance Program, \$3.5 million to fund housing counselors and outreach and education programs for homeowners, \$2.75 million to the Delaware Attorney General's office for continuing enforcement and fraud investigation initiatives, \$888,923 in grants to support legal representation for homeowners and \$500,000 to the state's new Mortgage Mediation Program. PENN SYLVANIA: Pennsylvania will send the bulk of its \$66M in settlement funds to its Homeowners' Emergency Mortgage Assistance Program, which funds loans for unemployed borrowers who use the money for mortgage payments. Pennsylvania began taking applications for the rebooted HEMAP on July 1. Read about it <u>here</u>.

ALL STATES: Capital One Financial Corp., which recently paid \$210 million over claims it misled credit-card customers, will pay \$12 million to resolve alleged violations against military families, the U.S. Justice Department said. Capital One will pay \$7 million to service members whose homes or motor vehicles were unlawfully seized under an agreement announced by the Justice Department and the Office of the Comptroller of the Currency. Even more good news:

The deadline to request an <u>independent foreclosure review</u> if borrowers believe their homes were unfairly foreclosed in 2010 or 2011 has been extended to September 30. The borrowers are eligible for the review to determine if they suffered financial injury as a result of errors during the foreclosure process, and whether they may be eligible to receive compensation. Servicers sent letters informing *4 million borrowers* of their rights to reviews, but there is concern that the letters were mistaken for "scam-mail," and were left unopened. The good news is that borrowers can request a review online by clicking <u>here</u>. *All requests for independent foreclosure reviews must be postmarked or submitted on line by September 30.*

If you're a responsible homeowner and are current on your mortgage payments but would like to refinance for a lower payment, help could be on the way. The White House has proposed a <u>plan</u> that would allow underwater homeowners to refinance at historically low rates. The plan is expected to save homeowners who are current on their payments an average of \$3,000 per year, giving borrowers the chance to rebuild equity in their homes.

WHAT DO YOU THINK?

Deadline August 13... The Reinvestment Fund (TRF) is assisting the Housing Alliance of Pennsylvania and the Philadelphia Regional Office of the HUD to monitor the impact that the Marcellus Shale activity has had on *Public Housing Authorities and Housing Choice Voucher participants in Pennsylvania, Maryland and West Virginia.* Overall, activities directly and indirectly tied to Marcellus Shale exploration and drilling have reportedly impacted a number of areas in **PA, MD and WV**, and TRF is taking a survey to try and understand the nature and extent of the impacts. HUD requests all Public Housing Authorities and Housing Choice Voucher Administrators in affected counties to take a few minutes and complete the survey received via email from Ira Goldstein of TRF. CONGRATULATIONS ARE IN ORDER

The White House and US Interagency Council on Homelessness honored 13 community leaders from across the country for their passionate and effective service to vulnerable children, youth, and families. The "Champions of Change in the Fight against Youth Homelessness" ceremony was held at the White House on July 12. Region III is very proud to say that two of the Champions are from Region III: Lisa Stambolis from <u>Health Care for the Homeless in Baltimore</u>, and Deborah Shore of the <u>Sasha Bruce Youthwork</u> in Washington, DC.

HUD has announced the FY 2012 <u>Self-help Homeownership Opportunity Program</u> (SHOP) awards. Of the <u>\$13.5</u> <u>million in grants</u> awarded, \$4,247,550 will go to the Housing Assistance Council in Washington, DC. Other grants were awarded to Community Frameworks in Bremerton, WA,; Habitat for Humanity International in Americus, GA and Tierra del Sol Housing Corporation, Western States Housing Consortium in Anthony, NM.

FHA LEADS THE WAY

Version 3.0 of Technology Open to Approved Lenders (TOTAL) Mortgage Scorecard was released July 21. The FHA TOTAL Scorecard was developed by HUD to evaluate the credit risk of FHA loans that are submitted to an automated underwriting system. This new release changes some optional data fields to required fields, in addition to adding review rules and error codes. The <u>People's Emergency Center</u> (PEC) was joined by dozens of legislators, community partners and area families to recognize the 25th anniversary of the McKinney Vento Homeless Assistance Act. Established in 1987, the McKinney-Vento Act was the first significant federal law in response to homelessness. "On any given night, more than 6,000 Philadelphians will spend the night sleeping in an emergency or transitional housing program, and a few hundred more will sleep outdoors," said Jane C.W. Vincent, Regional Administrator, HUD Region III. "But through partnerships between the government and community leaders, we're committed to the common vision of ending homelessness in the City through a continuum of housing and support services." On June 25 and 26, HUD and Department of Health and Human Services (HHS) Administration for Children and Families collaborated to provide a Capacity Building Workshop to community leaders in the City of Chester as part of the <u>Strong Cities</u>, <u>Strong Communities</u> (SC2) Initiative. James C. Shay, from the HUD Maryland office, and Darlene Tart, HHS Special Initiatives Coordinator, facilitated training on the basics of establishing and sustaining nonprofit organizations. The second day provided real time training in

responding to a Request for Proposal (RFP) for a grant announcement. The 35 community leaders and city staff in attendance took advantage of the interactive format to ask questions and offer real-world examples of the experiences and challenges they have faced, and received suggestions for building strong organizations. The highlight was the group's understanding that collaboration and communication is essential to the success of not only their individual missions, but overall success for the residents of Chester.

At the dedication of a Baltimore family's new home in the city's Stadium Place community, Governor Martin O'Malley pointed to a chart showing positive signs that the state's housing market is getting healthier. Read more about it <u>here</u>. In honor of June's National Homeownership Month, the DHCD launched the \$30 million Targeted Areas Initiative, a part of the Maryland Mortgage Program.

Baltimore's Red Line light rail project is scheduled to start construction in a few years, but you can already see a rendering of what it will look like in action. To complement the recent <u>Red Line Open Houses</u>, the MTA has <u>uploaded a video to YouTube</u> that will give Baltimoreans a sense of where the tracks will be, what will happen to areas around the stations, how above ground stops can be accessed, and much more.

The <u>Maryland Homefront</u> Veterans and Military Family Mortgage Program is a \$50 million program designed to help current and former military homebuyers. The program is slated to run until June 30, 2013 or until the program funds have been expended.

The Cambridge Mace's Lane neighborhood came together to celebrate the new look of their community, made possible through \$800,000 in community development block grant funding through the Maryland Department of Housing and Community Development (DHCD). The Mace's Lane improvements included installation of sidewalks, gutters, curbs, storm drains, street lights and road paving, and was one of 13 community development block grant projects that DHCD funded this year.

On July 3 the HUD West Virginia Field Office participated in the Huntington VA Medical Center's first anniversary of its downtown Huntington Homeless Veterans Resource Center. On July 19, the National Law Center on Homelessness and Poverty marked the 25th Anniversary of the McKinney-Vento Homeless Assistance Act, the first major federal legislation to address homelessness, at an event with U.S. Representatives Judy Biggert and Alcee L. Hastings. The event featured excerpts from Tom Morgan's upcoming documentary, "These Storied Streets," which shares the heartbreaking and inspiring stories of several homeless individuals and includes a voice-over by Academy Award winner Susan Sarandon. Twenty-five years after the McKinney-Vento Act, the 1987 law that has provided housing and other services to millions of people, their stories are still far too common. More than 3.5 million people will be homeless

As Rep. Van Hollen notes in the record, there are a great many counselors just like Mrs. Castro-Conroy. They are unsung first-responders in our no-holds-barred fight to preserve and protect the most precious financial asset families have - their home. Since the start of the foreclosure crisis in 2007, counselors with Maryland's HOPE

HUD WESTERN PENNSYLVANIA



HUD staff outlined the mission of the United States Interagency Council on Homelessness (USICH) and the goals of "Opening Doors," the Federal Strategic Plan to Prevent and End Homelessness, to the leadership of the <u>National</u> <u>Association for County Community and Economic Development</u> (NACCED) at the <u>National Association of Counties</u> (NACo) convention in Pittsburgh on July 13. Community representatives learned about aligning local, regional, state and federal goals through focused partnerships and planning. The Pittsburgh Commission on Human Relations and their partner, the University of Pittsburgh Center for Metropolitan Studies, have recently been awarded \$65,000 from HUD to examine barriers to housing for previously convicted persons. The Commission credits some of their success with the grant application to their participation in a HUD <u>Center for Faith Based and Neighborhood Partnerships</u> Capacity Building Workshop. The Pittsburgh Commission on Human Relations advocates for access to decent, affordable housing in communities of choice, and considers it to be an important housing policy issue. The research project will assist the Commission to meet the equal housing challenges of Pittsburgh



residents.
