## Senate Confirms Dana Wade as FHA Commissioner



WASHINGTON -U.S. Department of Housing and Urban Development Secretary Ben Carson applauded the confirmation of Dana Wade to serve as the Federal Housing Administration's (FHA) Commissioner. FHA currently insures more than 8 million sin-

gle family mortgages, almost 12,000 mortgages for multifamily properties, over 3,700 mortgages for residential care facilities, and nearly 100 mortgages for hospitals.

"I want to congratulate Dana Wade on her confirmation by the United States Senate to serve as the Commissioner of the Federal Housing Administration," said Secretary Carson. "Dana has been a tremendous asset to the Department and the Administration throughout her years of service, and I have full confidence in her ability to successfully lead FHA."

"I join Secretary Carson in congratulating Dana on her confirmation and welcoming her back to FHA, where I know she will do an outstanding job serving the American people. We are grateful to have her considerable talents and knowledge to help guide the agency as our nation pulls through this pandemic," said Deputy Secretary Brian Montgomery, who served as FHA Commissioner from 2005-2009; 2018-2020.

"I'm extremely grateful for this opportunity to hit the ground running during this critical time for our nation's housing markets," Commissioner Wade said.

Mrs. Wade previously served as Acting Federal Housing Commissioner and Assistant Secretary for Housing from July 2017 to June 2018, where she oversaw over 2,400 employees and implemented enhanced risk management and monitoring of FHA's \$1.3 trillion portfolio. Wade also served as a Program Associate Director for General Government at the Office of Management and Budget from December 2018 to December 2019, where she led budget oversight for six Executive Branch agencies with a keen focus on financial services, including HUD, and multiple independent agencies.

In Congress, she served in senior roles including Deputy Staff Director for the Senate Committee on Banking, Housing, and Urban Affairs and Deputy Staff Director for the Senate Committee on Appropriations under Senator Richard Shelby (R-AL). Wade holds an MBA from the Wharton School at the University of Pennsylvania and a BA in Economics from Georgetown University.

### **Secretary Carson Terminates 2015 AFFH Rule**


U.S. Department of Housing and Urban Development (HUD) Secretary Ben Carson announced the Department will ultimately terminate the Obama Administration's Affirmatively Furthering Fair Housing (AFFH) regulation issued in 2015, which proved to be complicated, costly, and ineffective.

This brand-new rule, called <u>Preserving Community and Neighborhood Choice</u>, defines fair housing broadly to mean housing that, among other attributes, is affordable, safe, decent, free of unlawful discrimination, and accessible under civil rights laws. It then defines "affirmatively furthering fair housing" to mean any action rationally related to promoting any of the above attributes of fair housing.

HUD remains able to terminate funding if it discovers, after investigation made pursuant to complaint or by its own volition, that a jurisdiction has not adhered to its commitment to AFFH.

Persons who believe they have experienced housing discrimination may file a complaint of discrimination by contacting HUD's Office of Fair Housing and Equal Opportunity at (800) 669-9777 or visiting <u>How to File a</u> <u>Complaint</u> on HUD's website. # Additional CARES ACT Funding For Homeless Populations & Coronavirus Recovery

"Homelessness was a major issue in some cities across our Nation long before a pandemic occurred, and unfortunately the dire living conditions of our most vulnerable Americans left many without a home to isolate in or proper medical and healthcare resources to defend themselves against this invisible enemy," said Secretary Carson. "As we continued to monitor the effects of COVID-19 in at risk communities, the Department and our partners worked quickly to respond to outbreaks and minimize the spread from hotspots to other locations. This increased funding to help provide for our homeless will make a difference now as we combat the coronavirus and inform longterm, innovative solutions for addressing homelessness in the future."

Congress has provided \$4 billion for HUD's ESG program for local governments to prevent, prepare

for, and respond to coronavirus among individuals and families who are homeless, receiving homeless assistance, or are at risk of becoming homeless. In total, HUD has allocated \$3.96 billion in ESG funding to impacted communities in every U.S. State and territory, and the remainder \$40 million is being utilized to provide technical assistance to build capacity of grantees in those communities receiving ESG funding.

The \$2.96 billion in funding allocated today can be used to:

- Make more emergency shelters available for homeless individuals and families.
- Operate emergency shelters by providing food, rent, security, maintenance, repair, fuel, equipment, insurance, utilities, furnishings, and supplies necessary for their operation.
- Provide Hotel/Motel Vouchers for homeless families and individuals.
- Provide essential services to people experiencing homelessness including childcare, education services, employment assistance, outpatient health services, legal services, mental health services, substance abuse treatment services, and transportation.

Prevent individuals from becoming homeless and rapidly rehouse homeless individuals.

# **HUD Awards \$472 Million to Public Housing**

WASHINGTON – The U.S. Department of Housing and Urban Development (HUD) Secretary Ben Carson announced \$472 million in CARES Act funding to help low income families during the coronavirus pandemic. This funding can be used by Public Housing Authorities to help families assisted by Housing Choice Vouchers (HCV) and Mainstream vouchers prevent, prepare for and respond to the coronavirus. The funding, made available by the CARES Act legislation President Trump signed into law on March 27, 2020, will be awarded to Public Housing Authorities across the Nation.

"This funding will provide additional resources to public housing authorities to make sure people have a decent, safe, and affordable place to call home," said HUD Secretary Ben Carson. "HUD continues to work with our public housing authorities to protect American families from this invisible enemy, including vulnerable residents in the Housing Choice Voucher Program. "

"These new funds are important and will go a long way to help low-income residents secure and retain affordable housing during this unprecedented time," said Hunter Kurtz, Assistant Secretary for Public and Indian Housing. "

The Housing Choice Voucher Program (HCV) includes the Mainstream Program which provides tenant-based vouchers that serve low-income households. The eligible coronavirus-related activities include, but are not limited to, the following:

• Procuring cleaning supplies and/or services to maintain safe and sanitary HCV units, including common areas of PHA-owned Project Based

Voucher (PBV) projects.

• Relocation of participating families to health units or other designated units for testing, hospitalization, or quarantine, or transportation to these locations to limit the exposure that could be caused by using mass transportation.

• Additional costs to supportive services vendors incurred due to coronavirus.

• Costs to retain or increase owner participation in the HCV Program, such as incentive or retention costs (e.g. the PHA offers owner an incentive payment to participate in recognition of added difficulties of making units available for HCV families to rent while stay-at-home orders or social distancing practices are in effect).

• Costs for providing childcare for the children of PHA staff that would not have otherwise been incurred (e.g. children are at home due to school closings, PHA staff are working outside of regular work schedules, etc).

## **CARES Act Funding for PBRA**

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) (P.L. 116-136) is providing \$1 billion of additional appropriations to Project-Based Rental Assistance (PBRA) to prevent, prepare for, and respond to coronavirus, including to maintain normal operations and take other necessary actions during the period that the program is impacted by coronavirus. HUD completed funding actions to provide \$800 million of CARES Act supplemental appropriations to approximately 16,500 properties with Section 8 PBRA contracts to maintain normal operations. These resources, in addition to amounts appropriated under the fiscal year 2020 appropriations Act, will help offset decreased tenant rent payments resulting from reduced tenant income. Consistent with current practice, the funds will also accommodate increases in vacancy payment claims that may occur due to COVID-19 related delays in moving-in new tenants. Secretary Carson toured the Village to learn about the services offered at the facility. Among them were job training from Goodwill Industries, the mobile food unit and pantry donor through Feeding North East Florida, the career closet from Jacksonville Transit Authority, Child Guidance/ Early Learning Center Therapeutic Services, and the Sulzbacher Mobile Medical Health Unit staff. "Reading is a fundamental part of learning; it certainly had an important impact on my life," said Secretary Ben Carson. "Through this summer reading series, we're helping kids to cultivate a love for reading, which is a skill that will serve them greatly for the rest of their lives."

"It was an honor to take part in Secretary Carson's summer reading series," said Congressman John Rutherford. "As the saying goes, first you learn to read, then you read to learn. A strong foundation in reading is critical for early childhood development and I thank Secretary Carson for putting America's children first."

HUD's <u>Book Rich Environments (BRE) Initiative</u> is a collaboration aimed to transform Public Housing Authorities (PHAs) into book rich environments by providing diverse, high quality books and other literacy tools to children and families living in

HUD-assisted housing to improve literacy outcomes and ensure all young people, regardless of background, have the tools they need to reach their full potential.

The effort is made possible by a partnership among the U.S. Department of Housing and Urban Development (HUD), the U.S. Department of Education (DoE), PHAs, public libraries and other local and national education partners. Last year, HUD celebrated the distribution of 1,000,000 books to children living in HUD -assisted households or participating in HUD programs.

Secretary Carson launched the EnVision Centers Initiative to form centralized resource hubs in communities across the country that provide people with the educational tools and support needed to excel. The Centers focus on four pillars of growth and success: economic empowerment, educational advancement, health and wellness, as well as character and leadership.

### **Kentucky EnVision Center Enters Innovative Saving Partnershhip**

The Henderson Housing Authority (HHA) EnVision Center entered a partnership with Henderson Municipal Power & Light (HMPL) to reduce electric power consumption by the residents at their property plus all office buildings. HHA and HMPL are working to convert all existing incandescent and compact fluorescent light to LED, which is estimated to save approximately 688,628-kilowatthours in electricity usage per year, or \$48,410 per year at current rates. HMPL is also estimated to save \$28,846 in annual power costs.

"The HUD Kentucky Office commends the initiative shown by Executive Director Bobbie Jarrett of the HHA EnVision Center in utilizing all available local partnerships to improve the quality of life of the residents in Henderson," said HUD Kentucky Office Director Peter Jackson. "These energy costs savings are remarkable and I'm proud of this part-

#### nership."

"HMPL has reimbursed the HHA for LED bulbs and fixtures, at a cost of \$115,994, and the HHA is providing labor to perform the lighting changeout," said Brad Bickett, Reliability Compliance Manager for HMPL.

"Recent studies show that converting to LED lighting is one of the most cost-effective electric conservation measures. Good quality light-emitting diode (LED) lighting is highly efficient, using much less energy and lasting much longer than incandescent and compact fluorescent lighting. LED technology also offers improved quality of lighting, while the prices continue to decrease due to improved manufacturing. Furthermore, LED lighting produces less heat, reducing the air conditioning load," added Bickett.

HHA was designated a HUD EnVision center in October 2019.

USDA partners with local suppliers whose workforce has been significantly impacted by the closure of restaurants, hotels, and other food service businesses. They purchase fresh produce, dairy, and meat products then connect with local organizations to distribute food boxes to families in need.

Marie Estela Cestero, spokesperson for Sor Isolina Ferré Centers expressed deep appreciation for the trust given to their organization to identify and distribute these food boxes to families in great need: "*With this feat we continue to honor the legacy of our founder, Sister Isolina Ferré, who said that the only life worth living is the one you live for others.*"

### **30th Anniversary of Americans With Disabilities Act**

The Office of Fair Housing and Equal Opportunity (FHEO) hosted a forum commemorating the 30th anniversary of the Americans with Disabilities Act (ADA). The forum, which began with opening remarks by FHEO Assistant Secretary Anna María Farías, consisted of a panel discussion that included representatives from the National Council on Independent Living and Access Living, a former head of the Department of Justice's Civil Rights Division, and a disability rights specialist with FHEO's Compliance and Disability Rights Division.

The panelists discussed the significance of the ground-breaking law, how the advocacy of the disability rights community helped to raise the public's awareness of the need for the law, and how the law continues to be used today to protect the rights of persons with disabilities.

The Act, which was signed into law by Former President George H.W. Bush on July 26, 1990, states that buildings and public places may not discriminate by having inaccessible facilities. The law also protects people with hearing impairments, people who have sensory impairments, the blind, and people with cognitive or intellectual disabilities. In addition, ADA holds that people with disabilities cannot be discriminated against in employment settings, either as applicants for a job or as workers, and covers a broad array of other issues pertaining to employment.

The idea originated from a weekly call that Kentucky Field Policy and Management Staff attend to discuss how Continuum of Care (CoC) partners, homeless service providers, and homeless populations are being impacted by the COVID-19 situation. It was on this call where homeless service partners expressed a need for clothes to replace those that were being destroyed for sheltered populations possibly exposed to the virus.

"During these unprecedented times of dealing with COVID-19, it is heartwarming to know that our Field Office Director Peter Jackson and our entire Kentucky team are still carrying out HUD's mission to serve our homeless community," said Denise Cleveland-Leggett, Southeast Regional Administrator. "It is critical during this time of severe need that we push forward so that the people that we serve hold onto hope and know that they can still dwell in possibilities."

"Whether it is providing program assistance, working through federal partnerships, or discussing new ideas with Agency partners, we are always looking to implement the Secretary's mission in an impactful way for HUD's local stakeholders," said Peter Jackson, Field Office Director for HUD Kentucky. "When a need was identified that we were able to assist with, it became our duty to use the tools we had available to find a way to make it happen."

Kentucky Field Office staff from the Offices of Community Planning and Development, Public and Indian Housing, Field Policy and Management, and the Office of Housing Counseling pitched in over 300 hundred pounds of clothes and shoes for men, women, and children to be donated to Homeless Service providers around Louisville, Kentucky.

## Asset Management Policy & Program Summary

- An OAMPO Memorandum, "Status of Management and Occupancy Reviews Performed by PBCAs," was issued on June 23, 2020 (<u>click here</u>). The memo explains the lifting of the suspension of MORs performed by PBCAs in locations where there are no restrictions by state or local law or ordinances to prevent them from doing so.
- <u>Mortgagee Letter 2020-09</u> "Implementation of the Coronavirus Aid, Relief, and Economic Security (CARES) Act Forbearance" was issued on April 10, 2020, and posted on <u>HUDClips</u>. The letter describes a standard forbearance protocol to reduce paperwork and streamline processing for multifamily borrowers, servicers, and lenders. These guidelines are in effect during the covered period of the CARES Act, which begins March 27, 2020 and continues until the earlier of the termination date of the national emergency declared by the President on March 13, 2020 or December 31, 2020.
- A DAS Memorandum, "Update on Budget Based Rent Adjustments for Properties Assisted under Project Rental Assistance Contracts (PRACs)" was issued on March 12, 2020, notifying owners that HUD is resuming routine processing of budget based rent adjustments to increase reserve for replacement deposits (click here). ## **Processing of Special Claims for Vacancy During Covid-19**

 OAMPO has issued a memorandum, "Processing of Special Claims for Vacancy During the COVID-19 Pandemic," which provides instructions for the processing of special claims for vacancy for properties affected by COVID-19 during the period of March 27, 2020 through September 30, 2020. During this time, MFH will accept vacancy claims for 60 days starting from the prior Tenant's Move-out Date as opposed to the Ready-for-Occupancy Date, in instances where preparation of the unit for occupancy was prevented due to the impact of COVID-19. # **Resources and Updates** <u>HUD Will Safely Resume Physical Inspections</u>

• WASHINGTON - U.S. Department of Housing and Urban Development (HUD) Secretary Ben Carson announced the Department will resume Real Estate Assessment Center (REAC) inspections of HUD multifamily and public housing properties and units under strict safety protocols during the national recovery from the COVID-19 pandemic.

REAC inspections are the assessment tool that ensures HUD assisted properties meet federal standards of health, safety, and accessibility. REAC inspections were paused due to the Coronavirus outbreak in March of 2020.

To keep the residents and staff of HUD properties safe during the inspection process, REAC will prioritize inspections in states and localities based on the latest COVID-19 data from Johns Hopkins University and health risk scoring methodology from the Harvard Global Health Institute. ### Exclusion from Annual Income of Temporary Employment from U.S. Census Bureau

• The Office of Multifamily Housing published Housing <u>Notice H20-06</u> on <u>HUDCLIPS</u>, "Exclusion from Annual Income of Temporary Employment from the U.S. Census Bureau." It provides for the exclusion of temporary income received from Census work.

# **Electronic Signature, Transmission and Storage Guidance Published**

• The Office of Multifamily Housing published <u>Housing Notice</u> (H 2020-4), "Electronic Signature, Transmission, and Storage – Guidance for Multifamily Assisted Housing Industry Partners." In particular, this Notice may support owners and agents of assisted multifamily housing who are impacted by COVID-19.

The Notice provides guidance on acceptable procedures for use of electronic signatures, transmission, and storage of documents and files. With the issuance of this Notice, HUD's multifamily industry partners are permitted to use electronic signatures and electronic file transmission and retention, but must do so in compliance with federal, state, and local laws.

HUD has received numerous COVID-19 inquiries from owners and agents asking about signatures, in-person meetings, and income verifications. Since this Notice helps to address many of those questions, please share it with your colleagues and networks.

# Work Aids: 3rd Party RCS Waivers

- A newly revised policy memo for waivers of the requirement for HUD 3<sup>rd</sup>-party RCS can be found in the Asset Management Policy library at <u>this link</u>. This new policy reduces some confusion and is also likely to reduce the number of cases where a waiver of the 3<sup>rd</sup>-party RCS requirement will be provided. The memo also provides some temporary new ability to address difficulties with RCS during the coronavirus pandemic.
- The <u>waiver request form</u> and current relevant <u>rent tables</u> referenced in the memo can also be found in the policy library using the links provided.
