

**Resident Opportunities and Self Sufficiency (ROSS) Program  
Project Summaries for Resident Service Delivery Models**

**Alaska**

**Alaska Housing Finance Corporation**

**\$93,666**

The Alaska Housing Finance Corporation has received a ROSS Resident Service Delivery Models grant that is designed to address the housekeeping needs of frail or "at-risk" elderly/disabled residents. This program will provide assistance to about 130 residents at Chugach Manor, Chugach View, Golden Ages, Golden Towers, and Southall Manor.

**Arizona**

**City of Phoenix Housing Department**

**\$200,000**

The City of Phoenix Housing Department has been awarded a ROSS Resident Service Delivery Models grant. This grant funds a program called Special Opportunities for Adult Residents (SOAR), which provides supportive services to 250 seniors and adult persons with disabilities living in the following developments: Luke Krohn Senior Center, Marcos de Niza Senior Center, Washington Manor, and McCarty Apartments. The Housing Department has partnered with the City's Human Services Department, the Area Agency on Aging, Lions Visions Center, and many others to provide integrated services that promote independent living. Proposed activities include case management, health and personal care, congregate services, and transportation.

**Maricopa County Housing Department**

**\$498,500**

The Maricopa Housing Department has received a ROSS Resident Service Delivery Models grant. The grant will provide supportive services for 1,106 residents from 899 public housing units. On-site activities will be administered at the Coffelt-La Moreaux (Phoenix West Valley) and Father Fidelis Kuban Homes (Guadeloupe East Valley) housing sites. Partnerships have been formed with Wyser Academy to coordinate technical efforts; with Friendly House to provide GED and English as Second Language classes; and with Maricopa Work Force Connection to provide resume writing and interview techniques. The program will provide computer skills, transportation assistance, child care, case management, advocacy, and financial literacy.

## **Arkansas**

### **Housing Authority of the City of Magnolia**

**\$54,250**

The Housing Authority of the City of Magnolia has received a ROSS Resident Service Delivery Models grant. The Housing Authority worked in conjunction with Area Agency on Aging of Southwest Arkansas (AASA) to establish an elderly supportive services program more than 20 years ago. The Housing Authority's recent grant will enable this successful partnership and effective program to continue to provide the following services: housekeeping, health screenings, congregate and home-delivered meal service, transportation, and various types of wellness programs. The grant will help supplement the salaries of the program employees, and provide supplies and equipment for the wellness program.

### **Housing Authority of the City of North Little Rock**

**\$150,000**

The Housing Authority of the City of North Little Rock has received a ROSS Resident Service Delivery Models grant to, with the assistance of community partners, assist residents in eliminating barriers between themselves and self-sufficiency. Some services to be offered include, but are not limited to, adult education, computer training, child care and transportation assistance, rehabilitation testing and training, entrepreneurship training, individual and family counseling, budget and homeownership counseling, resume writing, and interviewing.

### **Forrest City Housing Authority**

**\$150,000**

The Forrest City Housing Authority has received a ROSS Resident Service Delivery Models grant to address and eliminate the cycle of poverty experienced by residents who receive welfare. The Authority is proposing a coordinated approach that links the resources of the Authority, residents, local educational institutions, and other local organizations. The main partner in the program is East Arkansas Community College. This program will afford residents an opportunity to succeed and become self-sufficient through program/case management, educational, vocational, and job training, and supportive services.

## **California**

### **Housing Authority of the County of Merced**

**\$150,000**

The Housing Authority of the City of Merced has received a ROSS Resident Service Delivery Models grant that will provide supportive services for 150 residents from the Merced Residents Association, Atwater Association, and others from the 45 units identified. The grant will provide case management, training, employment, entrepreneurship, and child care. Merced County Office of Education will provide training to residents to develop marketable skills. Merced Community College will provide vocational education as well.

## **California continued**

### **Housing Authority of the County of Santa Cruz**

**\$150,000**

The Housing Authority of the County of Santa Cruz has received a ROSS Resident Service Delivery Models grant to address the problem of youth truancy and high school drop-out rates among welfare-to-work families living in public housing or Section 8. This program will enhance a newly formed partnership between the local welfare agency, health department, school district, and law enforcement to address the issues of youth education, training, and school enrollment. The ROSS grant will help fund a program coordinator at the Housing Authority and an Employment Training Specialist at the Human Resources Agency to focus on support services for at-risk youth in welfare-to-work households.

### **Housing Authority of the County of San Bernardino**

**\$500,000**

The Housing Authority of the County of San Bernardino has received a ROSS Resident Service Delivery Models grant. The Housing Authority and the County Department of Jobs and Employment Services (JESD) will form a partnership in order to transition 170 families now receiving Temporary Aid for Needy Families from welfare to work. The Housing Authority will utilize its "Advantage" program to provide training opportunities, jobs, and supportive services. JESD will engage participating families in an intensive case management approach. Other partners include education institutions, private employers, and supportive service providers.

### **Calexico Housing Authority**

**\$150,000**

The Calexico Housing Authority has received a ROSS Resident Service Delivery Models grant that will make comprehensive job and support services available to resident households affected by welfare reform. In partnership with local agencies such as the Department of Social Services, Workforce Investment Board (PIC), and the Calexico Family Resource Center, a coordinated package of services will help these families overcome obstacles to achieving economic self-sufficiency. The Housing Authority's Computer/Community Learning Center will provide on-site services and activities, including vocational training and educational courses. In addition, a small business development center will help resident small businesses.

### **Housing Authority of the County of Marin**

**\$200,000**

The Housing Authority of the County of Marin has received a ROSS Resident Service Delivery Models grant to support their highly successful Resident Support Project (RSP). RSP provides service coordination, case management, and an array of community services to senior and disabled residents of the Authority's five elderly/disabled public housing complexes. Direct services provided through this program include in-home support, home-delivered meals, transportation assistance, mental health

services, primary health care, money management, and vocational services. The primary goal of RSP is to assist frail senior and disabled residents to increase or maintain their independence by providing the supportive services they require to remain housed in the community.

### **California continued**

#### **San Diego Housing Commission**

**\$500,000**

The San Diego Housing Commission, in collaboration with community organizations, has received a ROSS Resident Service Delivery Models grant to provide a variety of direct and coordinated services to public housing residents that will result in economic self-sufficiency. The program will be carefully aligned with the existing Welfare-to-Work delivery system and will incorporate a number of "best practices" from both the local Welfare to Work model and successful subsidized housing programs around the country. Existing on-site Learning Opportunity Centers will be enhanced to bring virtual and actual linkages to the One-Stop Career Centers to access a comprehensive package of education, training, support services, and employer-linked services.

#### **Housing Authority of the City of Los Angeles**

**\$1,000,000**

The Housing Authority of the City of Los Angeles has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 5,337 residents in public housing. The grant will serve groups of public housing welfare recipients with major barriers to employment, those suffering from clinical depression, single mothers between the ages of 22 and 28, and persons with a criminal record. Teams of mental health, legal, and financial planning professionals will assist residents in overcoming these barriers.

#### **Area Housing Authority of the County of Ventura**

**\$54,250**

The Area Housing Authority of the County of Ventura has received a ROSS Resident Service Delivery Models grant to serve Florence Janus, Tafoya Terrace, and Whispering Oaks developments of elderly/disabled residents. The services will include wellness programs; supportive services; referrals/information about senior resources; telemarketing, fraud, elder-abuse/awareness; and transportation services. These things will be accomplished with the aid of ten partners led by Lutheran Social Services of Southern California.

### **Colorado**

#### **The Housing Authority of the City and County of**

**\$500,000**

The Housing Authority of the City and County of Denver has received a ROSS Resident Service Delivery Models grant which offers educational, life skills, and support services promoting subsidy-free living. Intensive case management and coordination of services with the Department of Human Services, the Mayor's Office of Employment and Training, and Catholic Charities are provided to 270 residents at eleven public housing developments.

## **Colorado continued**

### **City of Fort Collins Housing Authority**

**\$150,000**

The City of Fort Collins Housing Authority has received a ROSS Resident Service Delivery Models grant. This grant will provide the Housing Authority and its partners, the Larimer County Workforce Center and the Larimer County Department of Social Services, with funds to provide family self-sufficiency services to residents of Fort Collins.

### **Lakewood Housing Authority**

**\$75,000**

The Lakewood Housing Authority has received a ROSS Resident Service Delivery Models grant to provide scholarship assistance to conventional public housing residents and Section 8 residents. Scholarships will enable recipients to access child care, transportation, job training, and mental/physical health services, thus eliminating barriers to self-sufficiency. The Housing Authority and the community services division will work together to disburse, track the use of, and evaluate the effectiveness of scholarship funding.

## **Connecticut**

### **Meriden Housing Authority**

**\$150,000**

The Meriden Housing Authority has received a ROSS Resident Service Delivery Models grant that is a comprehensive effort designed to bring meaningful welfare-to-work programming to the population they serve. Building on the successes of current resident service program, the grant will fund on-site case workers, counseling, support services, developmentally appropriate program-related daycare, literacy and language classes, and homeownership facilitation. Extensive networking with established city agencies, such as the YWCA, Literacy Volunteers of America, and the Meriden Community Action Agency, will provide our residents the greatest opportunity to achieve vocational success.

## **Florida**

### **Housing Authority of the City of Orlando**

**\$200,000**

The Housing Authority of the City of Orlando has received a ROSS Resident Service Delivery Models grant that will provide supportive services to more than 250 residents in public housing. The program targets six of the Housing Authority's public housing developments: Meadow Lake Apartments, Johnson Manor, Lorna Doon Apartments, Reeves Terrace, Griffin Park, and Carver Court. The grant will provide a variety of services to the residents, including case management, health screening, exercise programs, wellness workshops, and field trips.

**Florida continued****Clearwater Housing Authority****\$500,000**

The Clearwater Housing Authority (CHA) has received a ROSS Resident Service Delivery Models grant. The funded program will be located in the CHA's Jasmine Courts and will target those families who have been affected by welfare reform and have an interest in working towards economic self-sufficiency and homeownership. CHA has developed extensive community agency support from such organizations as Advantage Training Systems, and Pinellas Opportunity Council. This program will include economic development, case management support services, goal setting, life skills, and educational and employment training.

**Georgia****Housing Authority of City of Lawrenceville****\$150,000**

The Housing Authority of the City of Lawrenceville has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 300 residents in public housing. The grant will allow the Authority to subcontract with Gwinnett Housing Resource Partnership, Family Dimensions, Department of Labor, Gwinnett Alliance with Youth, and Gwinnett Tech and Quality Care for Children. They will provide child care referrals; home ownership counseling/financial planning; counseling and case management; job search and assistance; peer leadership/adult literacy/GED; computer skills; and transportation.

**The Housing Authority of the City of Atlanta****\$1,000,000**

The Housing Authority of the City of Atlanta has received a ROSS Resident Service Delivery Models grant. The Work Force Enterprise Program (WFEP) of the Housing Authority of the City of Atlanta is a holistic program designed to prepare Public Housing and Section 8 participants for self-sufficiency. WFEP includes outreach/referral, case management/personal

development, orientation, substance abuse screening, motivation and visioning, life skills/career readiness training, technical training and internship/job placement, and follow-up. WFEP has a proven track record with 82 percent of WFEP graduates placed in full-time employment.

**Augusta Housing Authority****\$199,700**

The Augusta Housing Authority has received a ROSS Resident Service Delivery Models grant. The Housing Authority will provide assistance to elderly/disabled residents at 14 developments that will

include educational programming, transportation, and counseling. These services will be provided in partnership with numerous community service agencies.

## **Georgia continued**

### **Etowah Area Consolidated Housing Authority**

**\$150,000**

The Etowah Area Consolidated Housing Authority has received a ROSS Resident Service Delivery Models grant to provide supportive services through its Work Connections Program to 100 residents at eight public housing developments. The program will focus on a Career Development Center, based on the one-stop shop model. The PHA and partners will provide job skills training, job search, and housing counseling. Child care and transportation will further assist families become self-sufficient and ease the transition from welfare to work.

## **Illinois**

**\$150,000**

### **Housing Authority of the City of Bloomington**

The Housing Authority of the City of Bloomington has received a ROSS Resident Service Delivery Models grant to assist public housing residents in their efforts to become self-sufficient. The program focuses on Temporary Aid for Needy Families clients and residents that are affected by welfare reform, addressing needs in various areas. The program also addresses educational and employment needs by offering classes and training in computer/office technology. As a way to eliminate barriers, transportation and child care are offered for each participant.

### **Peoria Housing Authority**

**\$500,000**

The Peoria Housing Authority has received a ROSS Resident Service Delivery Models grant to assess all public housing non-elderly families and all Section 8 Family Self-Sufficiency (FSS) members. The FSS families and 225 public housing families who are not receiving Temporary Aid to Needy Families could most benefit from the Welfare-To-Work Network, which provides many area opportunities to become self-sufficient by guiding participants to job training, job retention, child care, and transportation services.

### **Housing Authority of the City of East St. Louis**

**\$500,000**

The Housing Authority of the City of East St. Louis has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 6,800 resident at Compers, John Robinson, John Deshields, Roosevelt, Griffin, Or Weathers, Landsome, Starnes, Emerson, N.Scattered, N.E Scattered,

Norman E.Owens, and S.E. Scattered.

## **Illinois continued**

### **Rockford Housing Authority**

**\$500,000**

The Rockford Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 231 residents of ten public housing developments. The Housing Authority will collaborate with the Goodwill Abilities Center, Youth Build Rockford, Rock Valley College, the City of Rockford Human Services Department, the Rosecrance Health Network, Illinois Growth Enterprise, Inc., and other local partners to offer case management, life skills training, GED training, computer and employment training, job placement and follow-up, child care, and transportation services. Substance abuse counseling will be provided on a case-by-case basis.

## **Indiana**

**\$500,000**

### **Indianapolis Housing Agency**

The Indianapolis Housing Agency has received a ROSS Resident Service Delivery Models grant that will provide economic self-sufficiency services to 480 families/residents residing at nine public housing developments. The Housing Agency and partners, which include Goodwill Industries of Central Indiana, Indianapolis Private Industry Council, Indiana Black Expo, and several others, will provide services that include the following activities: on-site GED and computer literacy classes, job readiness and placement services, case management and referrals, day care and after-school programs, and transportation services for working families.

## **Iowa**

### **City of Des Moines, Municipal Housing Agency**

**\$149,500**

The City of Des Moines Municipal Housing Agency has received a ROSS Resident Service Delivery Models grant that will provide case management and counseling, economic development training, job development and placement, child care, and transportation to families in public housing. The program will be integrated with other resident programs to ensure the best service to all residents. It will include assessment, regular case management, and follow-up for a year after the resident has been placed with a full- time job.

### **Iowa City Housing Authority**

**\$150,000**

The Iowa City Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 300 residents at Shamrock, Washington Street, and Muscatine Avenue.

**Kansas**

**Newton Housing Authority**

**\$200,000**

The Newton Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 350 elderly and disabled residents in public housing. The grant will provide the residents with homemakers and attendant care services, on-site companion friendly visiting services, transportation, and health and wellness programs. The Department on Aging in each of the three counties will administer the programs.

**City of Wichita Housing Authority**

**\$200,000**

The City of Wichita Housing Authority has received a ROSS Resident Service Delivery Models grant to serve 224 units for elderly and disabled persons in four locations (McLean Manor, Greenway Manor, Bernice Hutchersen, and Rosa Gragg). The services to be provided are blood pressure checks, wellness rooming, and friendly visits for the frail and at-risk.

**Kentucky**

**Housing Authority of Fulton**

**\$150,000**

The Housing Authority of Fulton has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 32 residents in public housing. Through partnerships with twelve other organizations, the Housing Authority will be able to provide critical services to support families in their transition from welfare dependency to self-sufficiency. These services include personal case management and mentoring, job skill training, and supportive services. Partners in the project include the Rotary Club, County Extension Service, Nursing Home, Even Start, Resident Council, and Kentucky Cabinet for Families and Children.

**Housing Authority of Hopkinsville**

**\$129,359**

The Housing Authority of Hopkinsville has received a ROSS Resident Service Delivery Models grant to provide supportive services to 110 residents at seven public housing developments. The grant will provide public housing welfare recipients with job training and job placement in the local

community. The program will provide GED testing, Test of Basic Adult Education courses, computer skills, life skills, job skills, and driver education. The program also provides services to "at risk" youth to remain drug-free and move from school to work, college, or technical school.

### **Housing Authority of Murray**

**\$54,250**

The Housing Authority of Murray has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 786 elderly residents in public housing. These services include transportation to critical services needed by elderly participants, health screening, nutrition assistance, recreation, and education. A wide range of partnerships have been developed to provide comprehensive services to participants, including Murray State University and the work experience and training program.

### **Kentucky continued**

#### **Housing Authority of Owensboro**

**\$132,000**

The Housing Authority of Owensboro (HAO) has received a ROSS Resident Service Delivery Models grant to provide the necessary funding to assist residents in overcoming significant barriers to employment and training. The ROSS program would enhance the HAO's resident-oriented Family Self-Sufficiency program by providing and enhancing child care services; computer, employability, and homeownership training; educational opportunities; and job search/placement counseling.

#### **Housing Authority of Jefferson County**

**\$54,250**

The Housing Authority of Jefferson County has received a ROSS Resident Service Delivery Models grant to provide supportive services to 89 elderly/disabled residents at Bishop Lane Plaza. This program will provide cash management coordination, health and personal care referrals, socialization activities, and transportation.

#### **Housing Authority of Bowling Green**

**\$54,250**

The Housing Authority of Bowling Green has received a ROSS Resident Service Delivery Models grant that will offer effective, efficient, and compassionate supportive services to 260 elderly/disabled residents. Eight community partner agencies will contribute in-kind services. The residents will receive case management services, transportation services, housekeeping and personal care, in addition to wellness training on preventative health care. These services will assist residents to remain in their own homes and enjoy an independent lifestyle.

### **Louisiana**

#### **BW Cooper Resident Management Corporation**

**\$100,000**

The BW Cooper Resident Management Corporation has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 334 residents in public housing. This grant will

provide critical services to improve the quality of life for the residents in New Orleans, Louisiana, Orleans Parish. These services will be provided in two phases, reflective of the ROSS 1999 and 2000 grant cycles. The services in phase one were on-site automated case management, job skill training, resident-owned business development, and child care support. Phase two involves entrepreneurial training, individual development accounts, a credit union microloan fund, resident success empowerment initiatives, a business association, and an academy for the arts.

## **Maryland**

### **Housing Authority of Baltimore**

**\$1,000,000**

The Housing Authority of Baltimore has received a ROSS Resident Service Delivery Models grant that will provide supportive services for 180 residents at Brooklyn Homes, Cherry Hill Homes, Douglas Homes, Flag House Courts, and ten other public housing developments. The Housing Authority, in partnership with Work Matters Jobs Plus, will offer classroom training for residents and micro-loans designed to help residents begin and maintain their own businesses.

### **Housing Authority of the City of Annapolis**

**\$54,250**

The Housing Authority of the City of Annapolis has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 40 residents at the Glenwood High Rise in Annapolis, Maryland. The grant will allow the authority to put into place its Enhancing Needy Residents Independence and Congregate Housing (ENRICH) that will enhance the comfort, health, mobility, and safety of residents at Glenwood. The grant will also provide emergency response services to vulnerable individuals and enable disabled residents to enter congregate housing.

### **Housing Opportunities Commission of Montgomery County**

**\$200,000**

The Housing Opportunities Commission of Montgomery County, Maryland, has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 500 residents at Arcola Towers, Elizabeth House, Holly Hall, and Waverly House. Through collaborative arrangements with Senior Nutrition, Mobile Medical, Area Agency on Aging, and others, the Housing Opportunities Commission will enhance available supportive services and help provide services not currently available. This will allow the elderly residents to remain independent as long as possible, reducing the need for institutionalization.

## **Massachusetts**

### **Holyoke Housing Authority**

**\$150,000**

The Holyoke Housing Authority has received a ROSS Resident Service Delivery Models grant that will offer career development support, family saving plans, homebuyer education program, computer courses, vocational skills course, English as Second Language courses, and business development courses to residents at Terrace and Toeffer apartments.

**Quincy Housing Authority****\$150,000**

The Quincy Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 93 residents at the Riverview Development.

**Massachusetts continued****Lynn Housing Authority****\$150,000**

The Lynn Housing Authority has received a ROSS Resident Service Delivery Models grant which will provide supportive services to 587 residents at Curwin Circle family housing development. The grant will allow the Housing Authority to subcontract with Operation Bootstrap and the Boys and Girls Club to provide basic adult education and after-school youth programs. In addition, funds will be used to provide an on-site computer lab for residents to provide skills needed for job placement.

**Cambridge Housing Authority****\$500,000**

The Cambridge Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 300 residents at 10 public housing developments. This grant will allow the Authority to subcontract with the Cambridge Office of Workforce Development, the Cambridge Community Learning Center, and the New England Community Technology Consulting Groups to provide vocational case management, job development, basic education and computer literacy, English as a Second Language, and management of two Community Computer Centers. The Authority will coordinate services and provide outreach, teach post-secondary education classes, and provide counseling services.

**Boston Housing Authority****\$473,445**

The Boston Housing Authority has received a ROSS Resident Service Delivery Models grant to develop an entrepreneurial development training program and microloan fund. It will provide opportunities for tenants from Bromley-Heath, Cathedral, Commonwealth, Lenox Street, and Mary Ellen McCormack housing developments to learn how to start businesses. Partnerships with the Center for Women Enterprise, Dorchester Bay Economic Development Corporation, and other federal grant programs will bring additional resources to the program, including support services for participants.

## **Minnesota**

### **Public Housing Agency of the City of Saint Paul**

**\$500,000**

The Public Housing Authority of the City of St. Paul with two major partners, St. Paul Public Schools and the Amherst Wilder Foundation, has received a ROSS Resident Service Delivery Model grant to provide employment-related and literacy services to 500 family residents in Dunedin Donough, McDonough Homes, Mt. Airy Homes, and Roosevelt Homes, and scattered sites. They will provide case management, employment, placement, retention, literacy, and educational computer classes at those housing sites.

## **Missouri**

### **Housing Authority of St. Louis County**

**\$150,000**

The Housing Authority of St. Louis County has received a ROSS Resident Service Delivery models grant that will provide supportive services to 100 residents in public housing. The Housing Authority is partnering with the local community labor unions, and public and private entities for the purpose of moving residents from Temporary Aid for Needy Families to self-sufficiency. The residents will be trained in the computer, construction, retail, and banking fields.

### **Housing Authority of the City of Columbia, Missouri**

**\$200,000**

The Housing Authority of the City of Columbia, Missouri, with its partner the University Senior Care Program, has received a ROSS Resident Service Delivery Models grant to implement strategies to increase opportunities for elderly and disabled residents of Oak and Paquin Towers to remain independent. This will be accomplished by providing preventative health services; comprehensive health assessments; staff at each Tower to coordinate local services and activities; transportation services for basic needs; on-site computer labs; and exercise programs. In total, these services should reduce early admission to nursing homes.

## **Nebraska**

### **Housing Authority of the County of Scotts Bluff**

**\$54,250**

The Housing Authority of the County of Scotts Bluff has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 106 residents at four public housing developments. The grant will allow the Housing Authority to provide supportive services to elderly residents in order to maintain their ability to live independently.

## **Nevada**

**Las Vegas Housing Authority****\$261,890**

The Las Vegas Housing Authority (LVHA) has received a ROSS Resident Service Delivery Model grant to continue to deliver supportive services to the elderly and persons with disabilities. LVHA has partnered with Catholic Charities of Southern Nevada to provide services to 390 residents. The supportive services are designed to promote independent living and wellness. Services include total home cleaning, personal care, telephone reassurance, neighborhood networks, meal preparations, adult day care, transportation, and case management.

**Nevada continued****Housing Authority of the City of Reno****\$150,000**

The Housing Authority of the City of Reno has received a ROSS Resident Service Delivery Models grant that will provide opportunities for welfare recipients living in public housing to become self sufficient. Child care and transportation will be provided to enable them to receive basic GED, ESL, or job retention training or, if working in a low-paying job without benefits, job improvement training. Skill assessment and career exploration will be available along with parenting and interpersonal skills classes. Financial and credit counseling will be stressed so residents can learn financial management skills.

**New Hampshire****\$54,250****Lebanon Housing Authority**

The Lebanon Housing Authority has received a ROSS Resident Service Delivery Models grant to provide supportive services to 166 residents at three public housing developments. The Lebanon Housing Authority will partner with the Upper Valley Senior Center, the Visiting Senior Center, the Visiting Nurse Alliance of Vermont and New Hampshire, The Upper Valley Ambulatory Geriatric Education Program, and the Falls Risk Prevention Project to offer its elderly/disabled residents additional services, such as case management, assistance with activities of daily living, and housekeeping. Residents will be helped by a Fitness Trainer to maintain their strength and reduce falls. Monthly forums at each location will inform residents about new developments in elderly care.

**Dover Housing Authority****\$200,000**

The Dover Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 274 elderly and disabled residents in public housing. The Dover Housing

Authority, together with the Wentworth Douglas Hospital and its home and health care agency, Squamscott Visiting Nurse and Hospice Care, will provide a supportive service program to residents living at Dover's elderly public housing complex. Services include homemaking, healthcare, and educational programs to help keep the elderly independent.

### **New Jersey**

#### **Housing Authority of the City of Rahway**

**\$148,905**

The Housing Authority of the City of Rahway has received a ROSS Resident Service Delivery Models grant to provide an innovative job placement/retention program to 72 residents at Rudy Scott Gardens, J.F.K. Apartments, and Glen Denying Homes. The Housing Authority will provide individualized services plans and job training for those in need of employment.

For those residents who are employed, the program will provide on-site job retention skills. Skills evaluation and goals planning will be provided for all participants.

### **New Jersey continued**

#### **Center for Hope, Hospice & Palliative Care**

**\$100,000**

The Center for Hope, Hospice and Palliative Care has received a ROSS Resident Service Delivery Models grant in conjunction with the Rahway Housing Authority Elderly Resident Empowerment Association and the Rahway Housing Authority. This partnership will provide elderly supportive services to the elderly residents of the three developments of the Rahway Housing Authority. These services will include meals, case management, transportation, housekeeping, personal care assistance, and wellness programs.

#### **Atlantic City Housing Authority**

**\$500,000**

The Atlantic City Housing Authority has received a ROSS Resident Service Delivery Models program that will aid 101 residents in five public housing developments. The program will provide employment opportunities and supportive services to assist residents in becoming self-sufficient, including computer training, child care, entrepreneur training, GED studies, life skills, literacy assessment, and other services.

#### **Housing Authority of the City of Perth Amboy**

**\$150,000**

The Housing Authority of the City of Perth Amboy has received a ROSS Resident Service Delivery Models grant for the residents of public housing. Services and programs shall include case management, a voluntary Family Self-Sufficiency Program, home-based child care, computer skills training employment training and counseling, child care and transportation assistance, education (remedial, literacy, ESL), personal welfare assistance, and homeownership.

**Housing Authority of the Borough of Highland Park****\$54,250**

The Housing Authority of the Borough of Highland Park has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 119 elderly and disabled residents at Park Terrace Apartments and S.J. Kronman Senior Apartments. In partnership with Easter Seals of New Jersey, the grant will provide the following services: housekeeping, personal care, health screening, transportation, and other wellness programs. This program will be the second location for the Easter Seals Assisted Living Supportive Services program.

**Housing Authority of the Township of Woodbridge****\$150,000**

The Housing Authority of the Township of Woodbridge has received a ROSS Resident Services Delivery Models grant that will provide supportive services needed by residents in the Woodbridge Garden Apartments to attain economic and personal self-sufficiency. Through this grant and partnerships with a wide range of organizations in the Woodbridge community, the program will offer case management, employment training and job readiness skills, computer-based education and skills training, and mentoring on personal well being. Among the partners are Woodbridge Township School District, Perth Amboy Center, Middlesex County Economic Opportunities Corp., and County of Middlesex Employment and Training Department.

**New Jersey continued****Garfield Housing Authority****\$200,000**

The Garfield Housing Authority (GHA) has received a ROSS Resident Service Delivery Models grant to provide supportive services to 375 residents of Golden Tower, Belmont Gardens, and Daniel P. Conte elderly developments. Partnering with Easter Seals of New Jersey, GHA will administer the ROSS grant funds for the Assisted Living Supportive Services Program. The grant will enable the Authority and Easter Seals to provide the following services: housekeeping, personal care, health screenings, meals services, and wellness and counseling programs.

**New York****Municipal Housing Authority of the City of New Rochelle****\$200,000**

The Municipal Housing Authority of the City of New Rochelle has received a ROSS Resident Service Delivery Models grant to serve four developments. The services provided will help elderly/disabled residents to live independently and to enjoy enhanced living quality through a case management system inclusive of health care services, congregate services, and transportation services.

**Cohoes Housing Authority****\$106,000**

The Cohoes Housing Authority has received a ROSS Resident Service Delivery Models grant to promote economic self-sufficiency, provide a savings escrow for families, and provide a means for working heads of households or spouses to increase earnings potential. This will be accomplished through case management and provision of college-level courses.

**Albany Housing Authority****\$500,000**

The Albany Housing Authority has received a ROSS Resident Service Delivery Models grant to establish an Arbor Hill Employment Project to empower residents of the Ida Yarbrough development to move from welfare to work. The project features the development and operation of a computer training facility, the establishment of a child care center, and the opening of a branch of The W.A.G.E. Center to provide targeted job readiness training and vocational case management. The project is operated by a partnership that includes the Albany Housing Authority, Albany County Department of Social Services, and several community-based organizations.

**New York continued****Rochester Housing Authority****\$500,000**

The Rochester Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 200 residents. This grant will allow the Housing Authority to collaborate with the Monroe County Department of Social Services, the Educational Opportunity Center, SUNY College of Brockport, the Rochester City School District, City of Rochester Department of Parks, Recreation and Human Services, the South West Area Neighborhood Association, Inc., the Monroe Community College, and other local partners to move residents into meaningful employment and self-sufficiency by providing a comprehensive program of supportive services and educational and training opportunities.

**New York City Housing Authority****\$1,000,000**

The New York City Housing Authority (NYCHA) has received a ROSS Resident Service Delivery Models grant to provide supportive service to 400 residents in nine districts in the city of New York. The program will assist underemployed NYCHA residents achieve self-sufficiency through the development of marketable skills and the provision of necessary services.

NYCHA will partner with the Wildcat Services Corp., who will train residents 3 nights a week. The program will enroll approximately 400 underemployed residents, at least 51 percent of whom are impacted by welfare reform. All participants will receive intake and assessment services, comprehensive skills testing, individual employment plan development, and case management services. In addition, the New York City Human Resources Administration will provide child care for program participants.

## **North Carolina**

### **Housing Authority of the City of Wilmington**

**\$500,000**

The Housing Authority of the City of Wilmington has received a ROSS Resident Service Delivery Models grant to provide supportive services to 175 residents in seven of its public housing developments to achieve economic self-sufficiency. To support its efforts, the Housing Authority will partner with ten community partners to ensure a full range of training and placement services.

## **Ohio**

### **Trumbull Homes Tenant Association**

**\$300,000**

The Trumbull Homes Tenant Association, and the public housing communities of Highland Terrace and Fairview Gardens have received a ROSS Resident Services Delivery Models grant that will provide 337 residents transportation, on-site child care, and individualized case management. Economic development training will be provided by Cushwa Center, and Trumbull County Department of Human Services will offer on-site seminars on the impact of welfare reform and job development awareness.

## **Ohio continued**

### **Dayton Metropolitan Housing Authority**

**\$300,000**

The Dayton Metropolitan Housing Authority has received a ROSS Resident Service Delivery Model grant to assist 382 elderly/disabled residents in maintaining their self-sufficiency by providing case management, housekeeping, assistance with daily living activities, congregate services, health and wellness education and intervention, and drug/alcohol abuse education and treatment. These programs will ensure frail elderly/disabled residents are not prematurely institutionalized and enjoy a better quality of life.

### **Portage Metropolitan Housing Authority**

**\$150,000**

The Portage Metropolitan Housing Authority (PHMA) has received a ROSS Resident Service Delivery Models grant which will provide supportive services to 76 area residents. The PMHA will provide opportunities for public housing residents to successfully transition from welfare to work and secure wages that exceed federal poverty guidelines. They will provide the following services, construction and building maintenance training, computer training, entrepreneurial training and counseling, transportation linkages/stipends, case management, child daycare, home ownership counseling and adult basic education, literacy and GED classes.

### **Zanesville Metropolitan Housing Authority**

**\$150,000**

The Zanesville Metropolitan Housing Authority has received a ROSS Resident Service Delivery Models

grant that will provide supportive services to 1,418 residents in public housing. Participating resident associations are Coopermill Manor, Race Circle, Maple Terrace Apartments, and many others. The grant will provide services in partnership with Muskingam County Health Services, Mid East Vocational School, Muskingam County Apartments, Human Services, and many others. The proposed services include child care, transportation, employment assessment, job coaching, job placement, and entrepreneurial training.

## **Oklahoma**

### **Housing Authority of the City of Tulsa**

**\$500,000**

The Housing Authority of the City of Tulsa has received a ROSS Resident Service Delivery Models grant that will enable it to retain eight Service Coordinators who will provide supportive services to an estimated 400 families at eight of its public housing developments. The funds will also help to provide transportation from the targeted sites, facilitating access to and from both job training/employment readiness services and work. Partners in this endeavor are the Metropolitan Tulsa Transit Authority, Family and Child Services, Goodwill Industries, and Index of Tulsa.

## **Oklahoma continued**

### **Housing Authority of the City of Muskogee**

**\$150,000**

The Housing Authority of the City of Muskogee will use a ROSS Resident Service Delivery Models grant to provide self-sufficiency activities to 450 residents. The activities include are comprehensive case management and extensive referral and service delivery systems.

### **Public Housing Authority of the City of Miami**

**\$54,250**

The Public Housing Authority of the City of Miami has received a ROSS Resident Services Delivery Models grant to provide supportive services to both its elderly and disabled residents in Nine Tribes Tower and Miami Towers. It is partnering with DOC Senior Service, Peliva Transit, and Grand Gateway to offer a wide range of services to elderly and disabled individuals in those facilities. Among these services are meals, housekeeping, personal care, transportation, and assistance with essential chores.

## **Oregon**

### **Housing Authority of Clackamas County**

**\$54,250**

The Housing Authority of Clackamas County has received a ROSS Resident Service Delivery Models grant that will provide case management assistance and activities for elderly and disabled public housing

residents to continue living independently and prevent premature institutionalization. The Housing Authority will provide these services to 115 residents in four public housing developments: Clackamas Heights, Oregon City, View Manor, Hillside Park, and Hillside Manor.

### **Housing Authority of the City of Salem**

**\$150,000**

The Housing Authority of the City of Salem has received a ROSS Resident Service Delivery Models grant to provide supportive services.

### **Housing Authority & Community Services Agency of Lane County**

**\$200,000**

The Housing Authority & Community Services Agency of Lane County has received a ROSS Resident Service Delivery Models grant. The Authority's Services Assisting Independent Living program (SAIL) links elderly and disabled public housing residents with seven agencies providing supportive services to increase self-sufficiency and promote housing stability. SAIL delivers successfully implemented services, including health care, transportation, case management and congregate services, on a locally determined basis (based on university-administered resident needs surveys). The grant will serve seven complexes throughout Lane County, ranging from rural apartments to suburban duplexes to urban high-rises.

## **Oregon continued**

### **Housing Authority of Portland**

**\$298,356**

The Housing Authority of Portland (HAP) has received a ROSS Resident Service Delivery Models grant to assist the elderly and disabled residents of public housing with the goal that they may continue to live independently. HAP runs and operates 2,810 public housing units. For the proposed ROSS program, HAP is targeting seven high-rise developments and will service 264 elderly and disabled residents. HAP joins with a number of partners to provide additional support service, such as Senior Companions, Health & Wellness Clinics, meals, transportation, housekeeping, and care management.

## **Pennsylvania**

### **Community Leadership Development Institute, Inc.**

**\$300,000**

The Community Leadership Development Institute has received a ROSS Resident Services Delivery Models grant to prepare low-income public housing residents with education, skills training, employment, entrepreneurship, and career mobility. In addition to assisting residents in the development of individual self-sufficiency development plans, the program will provide child care, service learning, and work exposure opportunities. The program will serve three Allegheny County Public Housing sites known as Hays Manor in McKees Rocks; Burns Heights in Duquesne; and Millvue Acres in Clairton. Specific program indicators will include, but are not limited to, selection of 90 residents to receive ROSS services, completion of individualized development plans for each

participant, establishment/maintenance of activity schedules, attendance and punctuality documentation, effective use of van services, the placement of at least 44, or 15 percent, of adult participants in employment, and assistance in the expansion of the Resident Council membership by at least 25 percent.

### **Philadelphia Housing Authority**

**\$1,000,000**

The Philadelphia Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide critical services needed by residents in 26 developments and scattered sites around the city. Through this grant and partnerships with a wide range of organizations in the Philadelphia community, the program will offer a wide range of services including case management, outreach and recruitment, job training opportunities, and supportive services. Partnerships with the Department of Public Welfare, Tenant Support Services, Inc., Philadelphia Workforce Development Corporation, Association Puertorriqueños, and Temple University have brought almost \$1,000,000 worth of in-kind contributions to support the program.

### **Pennsylvania continued**

#### **Housing Authority of the City of York**

**\$200,000**

The Housing Authority of the City of York has received a ROSS Resident Service Delivery Models grant to enhance independent living for elderly/disabled persons residing in Broad Park Manor through the partnership that has developed the Service Needed, Assistance Provided Program. This program will implement practical solutions and focus a comprehensive array of services to enhance independent living. The partners include York College of Pennsylvania; Broad Park Resident Council; York County Area Agency; White Rose Senior Center; and Bell Socialization Services. The key components include a wellness center, care management, congregate meals, assistance with daily activities, and a computer lab.

#### **Delaware County Housing Authority**

**\$200,000**

The Delaware County Housing Authority has received a ROSS Resident Service Delivery Models grant that enables the elderly and disabled populations of Delaware County Housing Authority to maintain independent living and prevent unnecessary institutionalization. Services to be provided include: outreach assessment and referral to community agencies, home health care, transportation, gardening, home monitoring system for emergencies, congregate activities, home-delivered meals, and heavy duty house cleaning to keep homes up to inspection standards. A variety of community agencies, such as

Community Transit and Home Nurse Inc., will assist in providing these services.

**Housing Authority of the County of Butler**

**\$100,000**

The Housing Authority of the county of Butler has received a ROSS Resident Service Delivery Models grant to provide supportive services for 441 residents at five public housing developments.

**Rhode Island**

**Housing Authority of the City of Woonsocket**

**\$100,000**

The Housing Authority of the City of Woonsocket has received a ROSS Resident Service Delivery Models grant for a program that is designed and aimed at the elderly/disabled residents of Kennedy, St.Germain and Parkview Manors, and Crepean Court. The program will target those elderly/disabled who are unable, temporarily or permanently, to perform the basic tasks. A personal task assistant will assist with the housekeeping and shopping services.

**Housing Authority of the City of Providence**

**\$500,000**

The Housing Authority of the City of Providence has received a ROSS Resident Service Delivery Models grant which will provide supportive services to 400 residents at six public housing developments and at scattered-site housing. The grant will allow the Housing Authority to provide residents with case management, education institution and computer skills training followed by job placement services.

**Rhode Island continued**

**Pawtucket Housing Authority**

**\$150,000**

The Pawtucket Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 500 residents at 560 Prospect Street and Galego Court housing developments. The grant will allow the Housing Authority to hire a Life Skills Coordinator to connect the residents to job training and placement resources and provide job retention counseling and mentoring. As a partner, the University of Rhode Island will provide computer skills training. Through the Housing Authority partnership with four agencies, supportive services will be provided, including Head Start, child care, transportation, life skills and leadership training, and referral to services.

**South Carolina**

**Housing Authority of the City of Columbia**

**\$499,919**

The Housing Authority of the City of Columbia has received a ROSS Resident Service Delivery Model grant to provide supportive services to 702 residents with the partnership of numerous community organizations. Since 1995, the Housing Authority has been providing family supportive services to assist public housing families become self sufficient. The thrust is to help those families on Temporary Aid for Needy Families and households with single females as

heads of household. The supportive services have been designed to eliminate, to the greatest extent possible, all financial and material barriers that impede the progress of the residents in their efforts to become economically self sufficient. The supportive services include, but are not limited to, case management, job development and placement, child care, financial aid, transportation, and any other professional or personal need deemed necessary to assist the residents in obtaining employment.

### **Myrtle Beach Housing Authority**

**\$150,000**

The Myrtle Beach Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 225 residents. The grant will allow the Housing Authority to partner with Helping Hands of Myrtle Beach, who will provide transportation, food, and medication, and the Waccamaw Center for Mental Health, who will provide on-the-job training as well as classroom training. The on-site activities will utilize the Legacy I apartment community, and will include computer training, financial counseling, and employment assessment.

### **Tennessee**

#### **Oak Ridge Housing Authority**

**\$150,000**

The Oak Ridge Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide support services to 45 residents in public housing. Most of the activities will take place in the Oak Ridge Housing Authority's Access Center. The grant will allow the Authority to subcontract with Anderson County Adult Center and Knoxville Area Career Center. The program's proposed activities are computer skills training, GED instruction, and pre-employment skills and training.

#### **Knoxville's Community Development Corporation**

**\$500,000**

Knoxville's Community Development Corporation has received a ROSS Resident Service Delivery Models grant that will help public housing and Section 8 residents build a bridge to self-sufficiency, enhancing supportive services that will be offered. The support includes transportation to the Career Investment Academy and to internships; and priority in Kids Base Childhood Learning Center; In My Place After School and Summer Program for elementary school students; and In The Shop After School and Summer Program for middle school students. A small part of the award will be used to construct a ramp and renovate a restroom at The Shop to make it

handicapped accessible.

## **Texas**

### **Housing Authority of the City of Dallas**

**\$500,000**

The Housing Authority of the City of Dallas has received a ROSS Resident Service Delivery Models grant which will provide supportive services to 2,627 residents at Elmer Scott, The Hamptons Lakewest, Edgar Ward, and Kingbridge Crossing.

### **Fort Worth Housing Authority**

**\$150,000**

The Fort Worth Housing Authority has received a ROSS Resident Service Delivery Model grant to meet the challenge of moving public and assisted housing residents from welfare dependency to work and self-sufficiency. The Housing Authority, in partnership with local organizations, will provide these services to four developments: Better Place, JA. Cavile, Ripley-Arnold, and Fair Park. These services will be administered at the Family Investment Center with centralized intake and assessment.

### **Housing Authority of the City of Houston**

**\$333,334**

The Housing Authority of the City of Houston has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 100 residents at 13 public housing developments. The grant will allow the Housing Authority to collaborate with the Employment & Training Centers, Gulf Coast Careers Center, and Walgreen Company to deliver job training and life skills training to its residents to enable them to obtain work.

## **Texas continued**

### **Housing Authority of the City of Austin**

**\$499,933**

The Housing Authority of the City Austin has received a ROSS Resident Service Delivery Models grant program that will help 260 public housing residents achieve self-sufficiency. The Housing Authority will work in conjunction with the Austin Community Nursery Schools, Goodwill Industries of Central Texas, Inc., and other community agencies to provide comprehensive training and supportive services. Specifically the Housing Authority will provide the following: assessment of skills and goals, case management, follow-up and support, on-site job training and job placement, child care, transportation assistance, and drop-out prevention services for middle school children.

### **Temple Housing Authority**

**\$150,000**

The Temple Housing Authority has received a ROSS Residents Service Delivery Models grant for a self-sufficiency project to serve 40 targeted welfare residents that reside in four public housing developments. The Housing Authority will improve its child care centers to meet HUD standards and be compatible for computer training. The program goal is to allow residents

to bridge knowledge gaps that prevent them holding jobs that will make them self-sufficient. It also provides education, employment, transportation, child care, and home ownership programs.

## **Utah**

### **Housing Authority of the County of Salt Lake**

**\$150,000**

The Housing Authority of the County of Salt Lake has received a ROSS Resident Service Delivery Models grant to provide housing assistance and supportive services to 364 low-income families in the community as they move from welfare to work and become economically self-sufficient.

## **Vermont**

### **Burlington Housing Authority**

**\$54,250**

The Burlington Housing Authority has received a ROSS Resident Service Delivery Models grant to expand a program that places a nurse in public housing and to develop supportive services for elderly/disabled residents. The objectives are to complete an assessment of residents utilizing an innovative comprehensive computer-based assessment tool, and coordinate referrals to existing services as indicated; coordinate and/or provide education and information pertinent to the resident's specific and aggregate health needs; and provide ongoing monitoring for residents identified as being at-risk.

## **Virginia**

### **Newport News Redevelopment and Housing Authority**

**\$500,000**

The Newport News Redevelopment and Housing Authority has received a ROSS Resident Service Delivery Models grant that will provide services to 1,000 residents at 12 public housing developments. The grant will allow the continued operation of the Family Investment Center, which provides classroom space for adults participating in education and training programs. Collaboration with the Office of Human Affairs, Catholic Charities, Newport News Public Schools, and many others including state and local agencies will enable families to take advantage of adult education, literacy programs, health services, credit counseling, nutrition education, and computer classes.

### **Danville Redevelopment and Housing Authority**

**\$150,000**

The Danville Redevelopment and Housing Authority has received a ROSS Resident Services Delivery Models grant to provide supportive services to hundreds of residents and families residing in five public housing developments. The Housing Authority and partners, which include the Danville Boys and Girls Club, Danville Community College, and the Danville Department of Human Services will provide counseling, job placement and retention assistance, child care, transportation, and other services to help

families move from welfare to work and working families sustain self-sufficiency.

**Fairfax County Department of Housing & Community**

**\$179,799**

The Fairfax County Department of Housing & Community Development has received a ROSS Resident Service Delivery Models grant that will provide supportive services to 75 disabled residents of the Audubon and Atrium public housing developments and a number of scattered sites. The program, which the Housing Authority calls the "Mental Health Residential Support" program, will provide on-site and in-home case management services, psychiatric and vocational rehabilitation, living skills training, and tenant education.

**Washington**

**Housing Authority of the City of Vancouver**

**\$149,969**

The Housing Authority of the City of Vancouver has received a ROSS Resident Service Delivery Models grant to provide supportive services to its residents. The ROSS program is supported by Pathways to Success, an innovative utilization of Clark County welfare-to-work agencies. By linking low-income residents with employment and education opportunities, Pathways to Success combines resources and effects system changes that will directly benefit public housing residents who seek economic self-sufficiency.

**Washington continued**

**Park Lake Community Council**

**\$100,000**

The Park Lake Community Council has received a ROSS Resident Service Delivery Models grant. The Park Lake Community Council Housing Authority will contract with Highline Community College to offer an enhanced education project at the Park Lake Career Development Center for Park Lake residents, especially Temporary Aid to Needy Families recipients. The college will provide either group or individual English as Second Language and literacy instruction as part of a career development plan based on a skills assessment, with realistic goals to get a job, keep a job, or progress to higher wages and benefits. Residents who desire to further their education will be linked to short-term vocational training at the college and supportive services to encourage success in their classes.

**Kitsap County Consolidated Housing Authority**

**\$150,000**

The Kitsap County Consolidated Housing Authority will receive a ROSS Resident Service Delivery Models grant to provide funding for the "HOMEOWNERSHIP DREAM TO REALITY" program that places emphasis on educating and preparing low-income adults for homeownership as they are going

through the welfare-to-work transition. Program components will focus on expanding housing counseling services to our public housing and Section 8 families. The program will consist of individual pre-purchase goal planning, budget and credit counseling, money management, first time homebuyer education classes, and workshops on minor home repair and maintenance.

**King County Housing Authority**

**\$500,000**
