### Alabama

**The Housing Authority of the City of Decatur** will receive \$250,000 to purchase and install security cameras and lighting at East Acres and Sterrs Homes to improve security and monitoring.

**The Housing Authority of the City of Evergreen** will receive \$250,000 to purchase and install security cameras, lighting and fencing at Evergreen Apartments to improve security and monitoring.

### Connecticut

**The East Hartford Housing Authority** will receive \$250,000 to purchase and install security cameras and lighting at Meadow Hill and Miller Gardens to improve security and monitoring.

### Florida
