## **Alabama**

AIDS Alabama targets homeless and chronically homeless individuals and families who are linked to medical care, case management, psychiatric assessment/treatment, social services, transportation, and basic living skills training. An estimated 14 households annually will receive these wrap around supportive services in order to promote housing stability. Additionally, 35 households will receive housing information services, and 13 will receive permanent housing placement annually. AIDS Alabama has collaborative partnerships with an extensive network of homeless service providers. The program utilizes the Homeless Management Information Systems (HMIS) in coordination with local continuum of care organizations.
