

FY 2003 HOPWA Formula Allocations

On March 3, 2003, HUD announced that \$259.304 million was allocated under the statutory formula to 111 HOPWA formula grantees, including 75 cities for Eligible Metropolitan Statistical Areas (EMSA's) and 36 States. The grantee for these amounts is the State or, for the EMSA, it is the most populous city within that area, which is the jurisdiction noted below. The State of New Jersey will administer funds for the four New Jersey Counties that are in the Philadelphia Metropolitan Area. In addition, Wake County, NC was again authorized to administer the grant to the Raleigh Metropolitan Area. Each of the allocations is made available under the jurisdiction's consolidated plan. The total program appropriation for fiscal year 2003 is \$290.102 million, including funds for competitive grants and training, oversight and technical assistance activities.

Three new FY2003 grantees are noted as (*) in the metropolitan area: Sarasota-Bradenton and the States of Colorado and Kansas. The new EMSA will reduce the prior service area of the State of Florida grant
