HERE'S HOPING 2001 IS A GREAT YEAR FOR IDIS (AND FOR OUR GRANTEES, TOO)

IDIS TRAINING FEB. 13-16 IN SEATTLE; NEW REPORTING WORKSHOP DEBUTS

Hands-on IDIS training takes to the road again in February after a brief hiatus in January. Trainers from TONYA, Inc. will be offering a brand-new one-day IDIS Reports Workshop. This class is geared to experienced IDIS users who want to learn how IDIS reports will help them better manage their programs while providing the details needed for the annual CAPER reporting process.

Also on the schedule is the one-day IDIS Plus workshop that debuted in Dallas this past December. IDIS Plus is designed for Entitlement users (as opposed to State users) who are experienced in using IDIS but who wish to expand their basic knowledge and use all features of IDIS.

Less experienced IDIS users will find the usual array of two-day classes for CDBG-only entitlements, multifunded entitlements, state HOME recipients, and state CDBG recipients. Also offered is the one-day class for state ESG and HOPWA recipients.

All sessions will be held at the West Coast Grand Hotel in Seattle. (Workshop registration deadline is January 12, 2001; Hotel registration deadline is January 15, 2001.) See the Training article in this issue for additional registration information. ■

WEB ACCESS USING INTERNET EXPLORER UPDATE

CPD and IT are continuing to develop web-based IDIS access for our Internet Explorer users. This task has proved formidable and we are currently working with our Web390 software vendor, Information Builders, Inc., to develop a process that is both robust and secure. TAU TOTALS FOR NOVEMBER

A total of 1,089 calls were received by the TAU during the month of November 2000. Less than one percent of the calls (7) concerned the HOPE 3 program and other non-IDIS calls, while over 99 percent of the calls (1,082) were associated with IDIS. All calls received by the TAU were answered by CSC customer service representatives, resulting in no voice mail for the month. ■

New IDIS Plus and Reports Workshops for Advanced Users; Training for States and Entitlements Continues

With the addition of the new IDIS Reports workshop, CPD now offers seven different IDIS workshops.

Workshops A through E are designed primarily to help new or less experienced users build the basic skills necessary to successfully navigate the IDIS system.

Entitlement grantees receiving only CDBG program funds should register for Workshop 'A.' Note: to ensure that the needs of all participants are addressed, the CDBG session has been expanded from one day to two days. This will give ample time to discuss IDIS reports and reporting.

Entitlement grantees receiving HOME funds (in addition to other program funds) should register for Workshop 'B,' the multi-funded, two-day session.

State grantees receiving HOPWA or ESG program funds should register for the one-day session, Workshop 'C.' State grantees receiving CDBG funds should register for the two-day Workshop 'D.'

State grantees receiving HOME funds should register for the two-day Workshop 'E.'

Experienced entitlement grantees may register for the one-day IDIS Plus Workshop 'F' or the one-day IDIS Reports Workshop 'G.' (When registering for the IDIS Plus Workshop, you will be asked to complete a brief survey which will help the instructors determine your level of expertise.) These workshops will be held "classroom style" in a separate room rather than combined with other workshops in "corners" of a larger room. We anticipate having 20 participants in each session and will have two trainers for each session. The emphasis will be on course content rather than on "hands-on" computer training although computers available will be used for portions of each workshop.
