## ESTIMATED HOME-ASSISTED UNITS ON MH02 MUST MATCH UNIT COUNT ON MH13 OR MH14 BEFORE ACTIVITY CAN BE COMPLETED

The HOME program office has been receiving a number of inquiries about an IDIS edit that requires the number of units entered on the HOME Completion "Characteristic Data" screens MH13 or MH14 to match the number of units entered for "Estimated HOME-Assisted Units" on the Rental\*Homebuyer\*Homeowner Rehab Setup (MH02) screen.

This is not a new edit and we plan to remove it in a future IDIS release. Until we do, grantees will need to adjust the "Estimated HOME-Assisted Units" on the Setup screen to match the number of actual units entered on the MH13 or MH14 screen. (For multi-address activities, this is the total unit count for *all* MH13 screens for the activity, not the units at one address.)

## YOUR FHEO AND PD&R RESOURCES FOR RACE AND ETHNICITY QUESTIONS

The Office of Management and Budget (OMB) recommends that HUD beneficiaries self-classify themselves by ethnicity and race. Where this is not feasible, grantees should make a best-guess effort to classify their beneficiaries by Hispanic ethnicity and one of the ten new race categories. We realize that from time to time questions may arise as to which race and ethnicity categories best fit a particular beneficiary.

Tino Calabia from the FHEO Office of Policy & Program Evaluation and Dianne T. Thompson of the PD&R Program Monitoring & Research Division have offered to assist grantees and HUD field office personnel who have questions about classifying CPD program beneficiaries into the new Hispanic ethnicity category or one of the ten new racial categories.

# Two IDIS INTERIM RELEASES NOW IN PRODUCTION

On Wednesday evening, 12/18/02, HUD released several changes to IDIS to correct problems created with the release of version 7.0. The changes were effective Thursday, 12/19/02.

- IDIS no longer checks that each HOME TBRA unit has a social security number entered prior to allowing the grantee to fund the activity. The social security number was removed from the MH06 data entry screen in Version 7.0.
- The View Activity Funding option on the Draw Menu now correctly includes funds that are completely committed and drawn in the calculation of each program's totals.
- When a user attempts to create a voucher, the Create Draw screen no longer displays a message that funds are not available, if, in fact, they are.
- EDI users should again be able to send record type I24 and I25 data without a problem. Plus, a problem that was occasionally causing submissions of record type I19 data to abend should now be corrected.
- The PR05 and PR07 Draw reports were incorrectly listing "Receivable" transactions as *Completed* draws. With this fix, the status of "Receivable" transactions has been changed from "Completed" to "Cancelled" and will display as "Cancelled" on the PR05 and PR07 reports. Future receivable transactions will also automatically be given a status of "Cancelled" by IDIS.

On Monday evening, 12/30/02, HUD released the following IDIS items to production as IDIS Version 7.0.1. They were available for use on Tuesday morning, December 31, 2002.

- In certain cases, the Setup Activity screen (MA04) is not properly formatting the Proposed and Actual Number of Units a user enters. Effective with Version 7.0.1, IDIS will properly format the Proposed and Actual Number of Units without leading zeros and not force a user to manually enter leading zeros to pad the field. In addition, users may enter "0" as a valid Proposed and Actual Number of Units.

- The Asian Pacific Islander and Hispanic rows under the "# Total" and "# Hispanic" on the following screens will be protected from data entry after April 1, 2004: CDBG Direct Benefit (MA05), ESG Racial/Ethnic Characteristics (ME07), and HOPWA Racial/Ethnic Characteristics (MP12).
- If an error in the number of persons belonging to the Asian Pacific Islander or Hispanic races in the "Displaced From," "Remain In," and "Relocated To" columns of a Census Tract or city on the CDBG Displacement Balance Resolution screen (MC07) is causing an out of balance situation, grantees will have an opportunity to correct the error if they failed to do so prior to March 31, 2004. This is the only case where existing Asian Pacific Islander or Hispanic race data can be changed after April 1, 2004.
- The CDBG Displacement screen (MC03) and the CDBG Displacement Balance Resolution screen (MC07) now properly highlight columns and rows that are out of balance.
- When a user presses F1 on a help-available field or F10 to add additional entries on the HOME Tenant-Based Rental Setup screen (MH06), IDIS will now allow data entry for all TBRA records on the screen. Users no longer need to press F9 to unprotect the records.
- The I14, EDI CDBG Area Displacement record, has been modified to reflect the online displacement edits on the MC03 screen:

Non-tract records (those not starting "9999.99") must not contain data for "Displaced From" or "Remain In."

For a displacement record, the value of "Remain In" Total must never exceed the value of "Displaced From" Total, and the value of "Remain In" Hispanic must never exceed the value of "Displaced From" Hispanic.

For a displacement record, the Hispanic value for a race must never exceed the Total value for a race within the Displaced From, Remain In, and Relocated To sections.
