

IDIS RELEASE NOTES FOR VERSION 5.0

The following IDIS items will be released to the production system environment as IDIS release version 5.0 on Friday, March 3, 2000 and available for use on Monday morning, March 6, 2000.

REPORT ENHANCEMENTS

IDIS reports that prompt the user for run-time parameters now display the selected parameters in the report headings. These reports include List of Activities (C04PR02), Grant Drawdown (C04PR05), Drawdown Voucher Summary (C04PR07), Grantee Summary Activity (C04PR08), and Program Income Details (C04PR09).

CORRECTIONS

The Maintain Drawdown screen (C04MD53) now properly displays more than 99 pages of vouchers, if there are that many pages available to display.

The Authorization screen (C04MD05), which is used jointly by the Drawdown and Receipts function, now displays the proper screen name and messages when used with the Receipts function.

The Initial Funding Date is now a display only field on the Process Activity screen (C04MA03). The value displayed is based on the date that you initially fund the activity using the Activity Funding screens.

When you copy a canceled or completed activity using the Copy/Move Activity screen (C04MA12), the newly created activity will have an initial status of 4, Funds Budgeted and the Initial Funding Date and Completion Date will be blank.

The Query Receipts Status screen (C04MI03) now properly displays the Amount fields.

The Query Receipts Audit Trail screen (C04MI04) now properly edits any values you enter in the Program Code, Fiscal Year, Source Type, Fund Type, and Date fields.

The HOME Rental Housing Location/Address screen (C04MH12) and the HOME Multi-Unit Cost Data screen (C04MH16) now display the correct messages when the F10, F13, and F18 keys are pressed.

You no longer see an error message when you select an address on the HOME Activity Location/Address view screen (C04MH62) and try to proceed to the HOME Characteristic Data screen (C04MH66).

The HOME Rental Housing Location/Address screen (C04MH12) now displays the correct error message if you inadvertently press the spacebar then press Enter (instead of selecting an address).

The HOME Characteristic Data screen (C04MH14) and the HOME Completion Downpayment Assistance screen (C04MH19) no longer display SQL error messages.

The HOPWA Funds screen (C04MP10) now properly displays all amounts.

The first detail line on the Float-Funded Activities report (C04PR13) now properly displays the Activity Number and National Objective Code.

The Grantee Summary Activity report (C04PR08) now properly displays activities that were moved to a different project or a different year.

The Grantee Summary Activity report (C04PR08) now properly displays the Grantee Activity Number.

If no data matches the selection criteria, the ESG Grantee Statistics for Program Year report (C04PR19) now displays report headings and the message, "No data available."

Three new codes were added to the original 13 codes used for EDI batch processing: 14=Loans, 15=Low/Mod Persons, and 16=Low/Mod Jobs.

When using the Pre-Production system, if you limit the display to one Plan Year on the Maintain Plan Project screen (C04MK04), the system now properly displays all projects for the year.

PERFORMANCE ENHANCEMENTS

Funding data is now more accurate. A one-time special program resolved some activity funding inconsistencies.

Data download files now properly display negative numbers.

The EDI batch process now properly processes address details (record type 104).

JCL code was modified to reflect the production libraries.

The date edit for July has been modified to accept 31 days.
