We surveyed the HOME Program administered by the West Virginia Housing Development Fund (WVHDF) to determine if the planning, processing, and construction of projects were completed in accordance with HUD regulations and requirements.

We interviewed HUD's Community Planning and Development staff, WVHDF staff, HOME Program originators, reviewed WVHDF and originator files, and visited seven HOME project sites.

No deficiencies were identified during site visits to the HOME properties or with the review of the WVHDF's files. No additional audit work is currently necessary.
