## Our Way Home: Strengthening Rental Assistance Essential for Housing Supply

Under Secretary Fudge's leadership, <u>Our Way Home</u>, is the U.S. Department of Housing and Urban Development's initiative that tells the story of how HUD boosts our nation's housing supply and brings down costs for all Americans. In their recent <u>Our Way Home blog post</u>, Victoria Brown, Deputy Chief of Staff, and Doug Rice, PIH Special Policy Advisor explain that expanding rental assistance is the most effective way to ensure that an adequate share of the housing supply is affordable to poorer renters, an essential part of the Biden-Harris Housing Supply Action Plan.

#### **New Incremental Housing Choice Vouchers**

On September 23, 2022, HUD Secretary Marcia L. Fudge <u>announced</u> the awarding of more than 19,000 new HCVs to almost 2,000 PHAs in nearly every community across the country. These vouchers were awarded through <u>PIH Notice 2022-29</u>, which provides guidance on the allocation of \$200 million through a formula that considers factors like severe cost burden, overcrowding, substandard housing for very low-income renters, and homelessness.

## **Extension of 120% Payment Standards Waivers**

HUD recently published PIH 2022-30, which extends through December 31, 2023 the currently approved regulatory waivers for increasing the payment standard and new payment standard amounts. This Notice includes regulatory waivers to assist PHAs in responding to ongoing fluctuations and disruptions in the rental market by providing more flexibility with establishing and applying payment standards. Waiver extension requests must be submitted by December 31, 2022 to increase payment standards, and new streamlined waiver requests must be submitted by September 30, 2023.

**Increased Funding for Additional Mainstream Vouchers** 

On September 30, 2022, HUD published <u>PIH 2022-31</u> to increase the amount of funding for Mainstream vouchers authorized by the CARES Act. The total amount of funding now available is \$48 million.

HUD recently published <u>new resources for HCV landlords</u> on its website to help bust myths and increase landlord participation in the program. These resources include info sheets, videos, and step-by-step guides for both prospective landlord participants and for PHAs to improve landlord engagement.

#### FY22 Choice Neighborhoods Implementation Funding Announcement Published

On September 30, 2022, HUD published the <u>FY22 Choice Neighborhoods Implementation</u> <u>Grant Notice of Funding Opportunity (NOFO)</u>, announcing the availability of an historically-high \$379 million in funding to communities across the country. HUD's press release is available here.

The application deadline is January 11, 2023. The maximum grant award is \$50 million, with PHAs, local governments, and/or tribal entities eligible to apply. HUD made several changes to this year's NOFO to streamline rating factors and clarify program requirements. In the coming weeks, HUD will publish frequently asked questions and a webinar for prospective applicants <a href="here">here</a>. PHAs are strongly encouraged to apply for a Choice Neighborhoods Planning or Implementation Grant when considering redevelopment of severely distressed public housing properties.

#### **New Flat Rent Process and Resources**

Beginning October 1, 2022, HUD has updated its flat rent exception request submission process for new requests and extension requests. The <u>flat rent website</u> explains the streamlined submission process in detail and <u>HUD's flat rent team</u> is available to answer questions. HUD requires PHAs to give families a choice of rent annually, based on the family's income or a "flat rent" amount generally based on 80% Fair Market Rents (FMRs). If the PHA believes that 80% of the FMR does not reflect the market conditions, then a HUD-approved flat rent exception request is required to set a lower flat rent. A notice outlining these updates is forthcoming.

## PHAs Selected for New Asset Building Moving to Work Demonstration Cohort

HUD has announced eighteen new Moving to Work PHAs as part of the Asset Building cohort. Through this new cohort, HUD will evaluate asset building activities that encourage the creation and growth of savings accounts and/or aim to build credit, through rent reporting, for assisted households. This cohort is a key component of HUD Secretary Marcia L. Fudge's economic justice agenda: Bridging the Wealth Gap. By integrating asset building, anti-poverty policies can more directly facilitate economic stability for millions of Americans.

## FY21 Choice Neighborhoods Implementation Grants Awarded



HUD Secretary Marcia L. Fudge, Tulsa Mayor G.T. Bynum, Tulsa Housing Authority Chief Executive Officer Aaron Darden, Tulsa City Councilor Vanessa Hill-Harper, community stakeholders, and residents celebrate a \$50 million Choice Neighborhoods Implementation Grant Award.

On September 22, HUD announced four new Choice Neighborhood Implementation Grants, totaling \$180 million, to the public housing authorities and cities of Durham, NC; Knoxville, TN; Omaha, NE; and Tulsa, OK. HUD leadership traveled to each of the four cities to celebrate the awards. Choice Neighborhoods Implementation Grants provide significant funding to (1) replace distressed HUD-assisted housing with new, high quality mixed-income housing; (2) invest in economic development and physical neighborhood improvement projects; and (3) support resident goals and outcomes related to income/employment, health, and education. **Choice Neighborhoods is a growing program and a priority for HUD**. The program's mixed-income housing approach is transforming neighborhoods nationwide and generating new housing opportunities for tens of thousands of families.

In Tulsa, Secretary Fudge noted Choice Neighborhoods grants are a "Testament to the benefits of a community-driven, whole-of-government approach to neighborhood revitalization. This is the kind of investment that excites me as Secretary of HUD. It excites me because I know that this is what it will take to ensure that every one of our nation's communities can thrive. When we invest in housing, when we build up communities and ensure that residents have access to grocery stores, schools, and health care, we can make a real difference in people's lives."
