HUD's Fiscal Year (FY) NOFA for the Choice Neighborhoods Initiative -- Round 1 NOFA Grant Program; Technical Correction and Extension of Deadline Date

**AGENCY**: Office of the Assistant Secretary for Public and Indian Housing and Office of Multifamily Programs, HUD.

**ACTION**: Notice of technical correction, and extension of deadline.

SUMMARY: On August 26, 2010, HUD posted on www.Grants.gov its Notice of Funding Availability (NOFA) for HUD's FY2010 Choice Neighborhoods Initiative -- Round 1. The NOFA made available approximately \$65 million in assistance for Planning and Implementation Grants thorough HUD's Choice Neighborhood Initiative, an initiative funded through the Consolidated Appropriations Act, 2010 (Pub. L. 111-117, approved December 16, 2009). In addition to establishing funding criteria and other requirements for applicants, HUD's FY2010 NOFA established October 26, 2010 as the deadline for applications. This notice announces that HUD is extending the October 26, 2010 deadline date for at least 30 days. HUD is extending the deadline for application to makes changes to the Mapping Tool used to determine neighborhood eligibility. HUD will post a subsequent notice with a new deadline date once the Mapping Tool has been revamped.

**DATE:** The new deadline will be at least 30 days after October 26, 2010.

On August 26, 2010, HUD posted on www.Grants.gov its Notice of Funding Availability (NOFA) for HUD's FY2010 Choice Neighborhoods Initiative -- Round 1. The NOFA made available approximately \$65 million in assistance for Planning and Implementation Grants thorough HUD's Choice Neighborhood Initiative, an initiative funded through the Consolidated Appropriations Act, 2010 (Pub. L. 111-117, approved December 16, 2009). Among other requirements, the FY2010 Choice Neighborhoods Initiative NOFA required that applicants respond to threshold requirements using the mapping tool provided at www.hud.gov/cn. In addition, applicants were required to provide other useful information that placed the project in the context of the city, county/parish, or municipality, neighborhood assets, and other revitalization activity underway or planned, using HUD's mapping tool.

HUD has identified a need to update its mapping tool to permit applicants to provide information that accurately maps neighborhood eligibility. In order to provide time to update its mapping tool, HUD has decided to extend the deadline date for applications by at least 30 days. HUD will post a subsequent notice on www.grants.gov with a new deadline date once the

Mapping Tool has been revamped. The notice will also provide detailed information on any additional changes to the NOFA as well as instructions for potential applicants on how to amend their applications.
